**1. DRAFT BOARD OBJECTIVES, 2002/03**

4.4 Monitor and review the impact of Council activities on communities

**Agreed** that the Community Advocate identify those projects which would be considered for second and third year funding.

In respect of the large financial commitment sought to fund Out of School Programmes, members considered that this was clearly a funding responsibility of Central Government.

(At the 30 January 2002 meeting the Community Board received the draft Out of School Programme Strategy, this followed on from the 1999 Out of School Programme Policy. One of the decisions taken then was for the Board to write to all local members of Parliament asking that the correct funding for these programmes should be from Central Government.)

1. That the Minister of Education (or his Associate Minister), together with the Opposition Education Spokesperson be invited to a Board-hosted meeting to discuss Central Government funding to Out of School Programmes.
  2. That this invitation be extended, also, to other Community Boards and interested community agencies/providers to attend.

### 3. OUT OF SCHOOL FUNDING, 2001/02

**Agreed**, that \$10,000 be allocated from Community Initiatives Fund to the Gilberthorpes OSCAR, and \$10,000 from Discretionary Fund to the Wharenui OSCAR.

### 4. ANTARCTIC HERITAGE TRUST

**Agreed** to a donation of \$100 and annual membership fee of \$100 to the Antarctic Heritage Trust, to be funded from Discretionary Funds.
