#### SUBMISSION ON ENVIRONMENT CANTERBURY'S DRAFT CLEAN AIR POLICY

#### **COMMUNITY BOARD PLANNING STATEMENT (KEY ISSUES)**

Part 1 of the process for the 2003/04 budget is the development of Community Board Planning Statements (Key Issues). Unfortunately the timetable for the entire process means that this statement has to be completed by 23 August. This is to enable the Key Issues to be considered by the Standing

Committees in the September round of meetings, when the previous year's monitoring reports are considered.

Part 2 of the process is the project proposals and substitutions, which are required to be completed by 13 September. Board members are reminded of the Council's statement in the 2003 Financial Plan and Programme, "The Council has set in place processes to identify opportunities to achieve considerable reductions and revenue increases in its operating budget totalling at least \$10m for the financial year 2005/06." The constraints referred need to be adhered to, while at the same time ensuring that the community's well-being is met.

## MEETING WITH NEIGHBOURHOOD SUPPORT GROUPS - SATURDAY, 20 JULY 2002

A meeting was held with approximately 25 representatives from Neighbourhood Support Groups from within Shirley/Papanui. The morning included introduction of the Community Constables, discussion from Pat Creasey on the Neighbourhood Support Conference and Neighbourhood Week. A presentation on ACC's Stay on Your Feet Initiative was well received. A session was held seeking information from those present on issues in the community and notes taken for future follow up.

#### NORTHERN PEGASUS BAY COAST VEHICLE ACCESS STRATEGY

At last month's meeting the Board decided to initiate a joint meeting on this issue with Burwood Pegasus and Hagley/Ferrymead to prepare a submission on the Strategy. Both Boards have indicated that they do not need to attend a joint meeting. It is therefore suggested that the submission be discussed at the Board's seminar meeting of 14 August 2002.

#### COMMUNITY BOARD CONFERENCE 2003, NEW PLYMOUTH - AWARDS
