# 7. ST PAUL'S PAPANUI – FUNDING REQUEST

The purpose of this report is to advise the Board of the proposals for St. Paul's Papanui 150 Years Jubilee Celebration, and request funding for a contribution towards the proposal.

### BACKGROUND

The Anglican Parish Church of St Pauls Papanui will have been in existence for 150 years next year and the parishioners will be celebrating in February 2003 the Jubilee of the Church. The celebrations will be held over the weekend 7 to 9 February 2003.

The Jubilee Committee has selected a project to mark this occasion, the project is seen as one which will not only enhance the grounds of the Church but also provide a service to the community of Papanui.

## THE PROJECT

The project involves the development of an area along the Harewood Road frontage into an attractive landscaped rest area that will overlook the Historic Church building. The site is significant because it will be alongside the site of the first St Paul's Church (1852-1877) and will be accessed from the side path entrance off Harewood Road.

The plan provides for a paved ara and fixed seating with a wall surround as a wind break. Parishioners, visitors and people in the community will be able to use the area to rest and relax.

In addition there will be a two sided information board in permanent materials, which will have information on one side about the history of the church and on the other side, historical information about early Papanui.

The project has been estimated to cost up to approximately \$15,000 which includes allowing for the sealing of the gravel pathway at a cost of about \$2,000.

The costs estimated are:

Wall	\$4,000
2 seats	\$2,000
Paving	\$2,500
Information Board	\$2,500

The details of the construction of the information board have not yet been finalised and consideration is being given to having a two sided sloping table like structure as seen in National Parks and Reserves.

To date \$6,500 has been donated by the parishioners in response to an invitation to contribute.

The Board is being requested to make a grant towards the cost of this project.

A plan of the proposal will be available at the meeting.

#### RECOMMENDATION

Should the Board wish to make a recommendation from Discretionary Funding, it may wish to consider the same as that donated, \$6500.
