8. SHIRLEY/PAPANUI CHILDREN'S DAY AT THE GROYNES

The purpose of this report is to inform of the outcomes of the Shirley/Papanui Children's Day Event.

Shirley/Papanui Children's Day at the Groynes was a free community event, funded by the Shirley/Papanui Community Board and co-ordinated by Christchurch City Council Leisure.

Shirley/Papanui Children's Day at the Groynes was held on National Children's Day, Sunday 27 October 2002. The day was for the whole family with lots of fun and free activities. Approximately 2500-3000 people attending the event. The impending bad weather may have had an impact on the afternoon attendance.

Approximately 200 posters were created to advertise Children's Day at the Groynes. 100 of these posters were put up in commercial premises in the Shirley/Papanui Board area. The remaining posters were displayed at City Council service centres and sent to schools, Residents Associations and other community groups in the Shirley/Papanui area. 3000 bookmark of the same design were also created and sent to schools and to the Shirley and Papanui libraries to hand out to children when they visited the library. The event was also promoted on the Christchurch City Council's Be There events website, in the Northern Mail and the Christchurch Star.

The event provided a variety of free activities for children and their families including a bouncy castle, the human fly, boats to ride on the lake, a noddy train, face painting, colouring competition, flax weaving, rock painting workshop and the McEwings climbing wall. There was also a free BBQ and other food vendors on site.

The stage, which was a key feature of Children's Day, showcased much talent and hilarity throughout the event. Directed by a fantastic MC Chris Martin, the stage schedule consisted of children's stage performers and a line up of talented local children.
