The purpose of this report is to submit for the Board's consideration the report and recommendations of the Committee as follows.

Report of a meeting of the Community Services Committee held on Friday 13 September 2002 at 8.30 am in Meeting Room 1, CCC Fendalton and at site visits

1. APOLOGIES

Apologies were received and accepted from Sally Buck and Mark Kunnen for early departure at 9.24 am.

2. COTSWOLD PRESCHOOL AND NURSERY - LEGAL ART PROJECT

The Legal Arts Adviser presented details of a legal art work proposed to be undertaken at the Cotswold Preschool and Nursery and sought funding assistance from the Board to complete the project.

The proposal was generally supported albeit a reservation was expressed at the amount likely to be paid to the Artist involved.

The Committee **agreed** that opportunities for suitable locations for Legal Art projects in the local community be further investigated by the Board's Public Art Project Working Party.
