

## 16. MARSHLAND ROAD - SHIRLEY ROAD TO PRESTONS ROAD

The purpose of this report is to seek Board approval to consult with the community on the proposal to provide on-road cycle lanes in Marshland Road from Shirley Road to Prestons Road.

### BACKGROUND

Marshland Road is a minor arterial road and runs from Shirley Road to Main North Road. In 2003/04/05 budget has been provided to upgrade and place on-road cycle lanes on Marshland Road from Shirley Road to Prestons Road.

The original scope of the project was for cycle lanes to Prestons Road. The Project Team was asked to look at extending this to Turners Road. This however was beyond the available budget so the project is back to its original scoping.

### DISCUSSION

As this is a very long section of road the project has been broken down into four (4) sections (see attached plans. A3 plans sent under separate cover):

- Shirley Road to Joy Street.
- Joy Street to Briggs Road.
- Briggs Road to Mairehau Road.
- Mairehau Road to Prestons Road.

#### Section One – Shirley Road to Joy Street

The cycle lanes from Shirley Road to Hercules Street are already marked at the new standard and there are no changes in this section. From Hercules Street to Joy Street the carriageway is 17 metres wide and it is proposed that the cycle lanes be remarked to the new standard (1.6 metres against the kerb, 1.8 against parked vehicles). The current lane widths are considered to be significantly substandard. This will result in the traffic lanes being narrower but the flush median and parking facilities will not be altered.

#### Section Two – Joy Street to Briggs Road

The carriageway width through this section of Marshland Road is only 13.5 metres. This does not allow for parking on both sides of the road, two traffic lanes and cycle lanes. The proposal is to remove parking on the east side and allow parking on the west side where the majority of properties are residential, have two traffic lanes and a cycle lane on both sides, and continue the flush median.

#### Section Three – Briggs Road to Mairehau Road

This section has no parking on both sides, cycle lanes on both sides and a flush median. The parking is already banned between Briggs Road and Queen Elizabeth II Drive and there is no demand for parking between Q E II Drive and Mairehau Road.

It is proposed to upgrade the access through and around the roundabout at Queen Elizabeth II Drive by realigning or providing a new pathway across the approach islands.

#### Section Four – Mairehau Road to Prestons Road

The proposal for this section of Marshland Road is to continue the cycle lanes on the road shoulder. They will combine into the existing cycle lanes that were established last year from number 382 north. This section has two areas of red cycle lane surface. They are proposed across the intersections with Mairehau and McSaveney Roads and will provide safety benefits to cyclists.

It was proposed originally to consult with property owners north of Queen Elizabeth II Drive prior to community consultation as they were the only properties that were affected with the loss of parking in the original proposals. However, the proposal has now changed and at this time no consultation has taken place.

The proposal for cycle lanes on Marshland Road meets the policy for cycle facilities and traffic management on arterial roads, the cycle strategy and the parking strategy.

The estimated cost of this project is \$150,000.

#### **CONCLUSION**

It is proposed to communicate the proposal to all property owners and residents by the delivery or mailing of a pamphlet. Council officers intend to visit all properties that will have a loss of on-street parking to explain the proposals.

This report will also be going to the Burwood Pegasus Board on 16 February 2004 to seek their approval to consult.
