2. DEPUTATION BY APPOINTMENT

2.1 BRYNLEY STREET/OAKHAMPTON STREET/TOWER STREET - TRAFFIC ISSUES

Graham Brown and Cathy Andrell are residents of Brynley Street, who wish to address the Committee on various traffic concerns in relation to the roundabouts at Brynley Street/Oakhampton Street.

Residents' concerns relate to the misuse of the roundabouts by heavy vehicles and buses which are doing 360 degree turns back up to Tower Street on the basis that they cannot safely manoeuvre around the Tower Street round about.

Other issues relate to the speed of through traffic, minor accidents and vehicles travelling through the roundabouts on the wrong side of the road.

Transport and City Streets Unit have employed a consultant to look at the issues in this area and their report is due to be received within the next two months.

3. CHALMERS STREET LINK – DRAFT TRANSPORT ASSESSMENT

At its 23 September 2004 meeting, the Board approved funding to assist with a scoping study on a possible Chalmers Street link road.

The report from Traffic Design (dated April 2005) was recently circulated to members for information.

At its 14 June 2005 meeting, the Board agreed that this report be received at this Transport and Roading Committee meeting.
