PURPOSE OF REPORT

1. The purpose of this report is to present to the Small Projects Funding Committee for its consideration the applications to the Shirley/Papanui Small Projects Fund for 2008/09 and to seek approval for the allocations under delegated authority.

EXECUTIVE SUMMARY

- 2. The Council adopted the Strengthening Communities Strategy on 12 July 2007. The Strategy incorporated the Community Group Grants Review which provided the framework, principles and funding outcomes for the new Strengthening Communities Grants Funding Programme. This programme replaces the Project and Discretionary Funding process as previously used by the community boards.
- 3. The Strengthening Communities Grants Funding Programme comprises four new funding schemes, which supersede all previous community group grant schemes, sub-schemes and categories. The new schemes are:
 - (a) Strengthening Communities Fund
 - (b) Small Projects Fund
 - (c) Discretionary Response Fund
 - (d) Community Organisations Loan Scheme
- 4. The new funding schemes enable Council and its community boards to support and provide leverage opportunities for not-for-profit, community focused groups seeking funding in support of their community endeavours. Detail of the outcomes, priorities and criteria of the new scheme are included in the background section of this report.
- 5. This report deals specifically with the Board's allocations for the Small Projects Fund for Shirley/Papanui. The total available for the Shirley/Papanui Community Board to allocate in 2008/09 is \$85,000.

The Decision Matrix

- 6. Detailed information on each applicant's project is presented in a decision matrix (matrix **attached**). The matrix names the organisation applying for funding and clearly describes the individual project applied for, including up to four project goals that will be delivered via the project. Details of alignment with Council strategies and Board objectives is provided as well as historical background to projects and applicants where applicable. The matrix also includes staff recommendations for funding.
- 7. Under the Small Projects Funding Scheme, organisations were asked to make applications for 'project-based' costs, in order to show where ratepayers money was being spent and what outcomes were being achieved. As such, organisations may have made more than one application in order to fund separate projects and deliver a range of services.
- 8. The final matrix includes 49 applications for funding with a total amount requested of \$111,133 and a total amount recommended by staff of \$85,000.

Timeline and Process

9. After the Committee has met and allocated the available funding (on 14 August 2008), all groups will be informed of the outcome of their application. All funding approved is for the period of 1 September to 31 August each year, therefore grants for this year will be paid out in early September 2008.

FINANCIAL IMPLICATIONS

10. Each Christchurch city community board has \$85,000 to allocate through the Small Projects Fund process and \$60,000 available in its Discretionary Response Fund, which is dealt with separately to this process and report.

BACKGROUND

- 16. The following funding outcomes have been used to evaluate and assess applications to the Small Projects Fund:
 - Support, develop and promote the capacity and sustainability of community recreation, sports, arts, heritage and environment groups;
 - Increase participation in and awareness of community, recreation, sports, arts, heritage and environment groups, programmes and local events;
 - Increase community engagement in local decision making;
 - Enhance community and neighbourhood safety;
 - Provide community based programmes which enhance basic life skills;
 - Reduce or overcome barriers to participation; and
 - Foster collaborative responses to areas of identified need.
- 17. The following priorities have been taken into consideration when assessing applications:
 - Older Adults;
 - Children and Youth;
 - People with Disabilities;
 - Ethnic and Culturally Diverse Groups;
 - Disadvantaged and/or Socially Excluded;
 - Capacity of Community Organisations; and
 - Civic Engagement.
- 18. Each community board's objectives were also taken into consideration when assessing applications.
- 19. Core criteria for applicants to the Small Projects fund are:
 - Not-for-profit, community-focused groups/organisations;
 - Legal status;
 - Based in Christchurch City Council (CCC) area and programmes primarily for CCC residents;
 - No unresolved previous accountability requirements and no overdue debts to CCC;
 - Must provide evidence of the project need;
 - Must have appropriate financial management, accounting, monitoring and reporting practices;
 - Applications must show evidence of authorised approval to seek funding from CCC; and
 - Must have sound governance, operational capacity and capability to deliver.
- 20. In making recommendations, and so as to ensure the consistency of recommendations with regard to all applications, staff held inter-unit collaboration meetings. At the meetings, individual applications were discussed and critically assessed. The meetings included staff members from Community Development, Community Engagement, Recreation and Sports, Greenspace and Democracy Services.
- 21. All applications appearing on the Decision Matrix have been assigned a Priority Rating. The current Priorities Ratings are as follows:
 - 1. Meets all eligibility and criteria and contributes significantly to Funding Outcomes and Priorities Highly recommended for funding.

- 2. (a) Meets all eligibility and criteria and contributes to Funding Outcomes and Priorities - Recommended for funding.
 - (b) Meets all eligibility and criteria and contributes to Funding Outcomes and Priorities - Not recommended for funding due to insufficient funds being available.

Staff comments including evidence of need:

This application has been considered Priority 1 as the project takes a community recreation approach targeting grass roots participation and is increasing the capacity of the network and youth to deliver quality recreation experiences for the youth.

Belfast - A community in transition recreation and community services needs analysis - September 1996 A Community Survey of Belfast Community and Recreation needs analysis and Community Facility plan for Belfast May 2006 Dr. Lesley McMillan's research (2003) "Investing in the Next Generation" recommended that "the Christchurch City Council continues to support Out Of School Programmes as an effective way of meeting the policy goals and supporting children and their families".

Youth programmes in particular are in high demand in most communities throughout Shirley/Papanui. The Belfast Cafe offers youth a regular programme were they can hang out and enjoy a range of recreation activities. A number of highly successful Youth Events have been run in the Shirley/Papanui community, however, as prices increase it is important to enable Youth to access smaller local events.

Staff comments including evidence of need:

This application has been considered Priority 1 due to the reach of the project.

Belfast Community Network responded to a Community Board initiated needs analysis that indicated that there was a need for coordination of services, programmes and activities in the Belfast area. The Network continues to respond to needs identified by and within the community. This organisation is the prime provider of social and community services in the Belfast area. Belfast is a suburb significantly impacted upon by growth and development north of the Waimakariri River. The Urban Development Strategy recognises this by designating Belfast as an "urban hub". The Network is also the major vehicle through which community, social, cultural and recreational organisations in Belfast co-operate.

The Belfast Friendly Clubs basic purpose is to provide regular opportunities for the elderly Belfast residents to keep their minds active, expand their interests and to enjoy the fellowship of new friends. The Belfast Friendly Club has been running for 33 years and has 40+ members. The group meets every fortnight either to have an entertainer or an activity or to go on a trip. Current rises in petrol and food costs has meant many of the members can no longer afford to go on the trips.

Probus is an association of retired and semi-retired people who join together in clubs, the basic purpose of which is to provide regular opportunities for them to keep their minds active, expand their interests and to enjoy the fellowship of new friends. The Belfast/Redwood Combined Probus has been running for 23 years and has 60 members. The group meets fortnightly either to have a speaker or to go on a trip. Current rises in petrol and food costs has meant many of the members can no longer afford to go on the trips. This trip will cater for 50 people.

The programme also includes an array of giveaways to excite young cricketers such as a MILO Have-A-Go Cricket cap, posters, player cards, sipper bottle, ball, sticker, certificate and MILO sample. The Harewood Cricket Club is one of three clubs that run this programme over the summer. The club has run programmes in conjunction with Riccarton over the last three years. Next season will see Riccarton move back to Hagley Park. This move has significant impact on the programme as Riccarton supplied a large amount of gear for the programme. The numbers at the programme have steadily increased and last year they had 70 children involved in the programme to be successful the club needs to train at least 5 volunteer coaches to Level 1 coaching standard and have another 5 Milo Have a Go trained volunteers to assist. The club likes to reimburse all volunteers but there is a charge for level 1.

The Kiwi cricket equipment the club needs to purchase is specially modified so juniors can participate and be successful.

This organisation is responsible for operating and managing Te Koru Pou Iho (the Papanui Youth Facility). As a major facility (and the only purpose-built youth facility) in Christchurch this organisation has benefits to the city well beyond the Shirley/Papanui Community Board area. The Trust attempts to provide collaboration amongst other organisations (particularly youth organisations) through making the facility available to a wide range of youth (and other) organisations. The Trust also acts as the umbrella organisation for Whakaoho - the Papanui Community event that is a collaborative event by numerous organisations in the Papanui and surrounding area. The Rock climbing programme ran for the first time last year. The programme uses rock climbing and outdoor activities as a tool for the development and change. The evaluations from this Programme were excellent. These were taken both from teachers, parents and the participants The Intermediate School Principal has indicated that they believe it is an extremely worthwhile programme with some outstanding results. The programme works with children that are referred by staff of the school, these children are chosen for a number of reasons. e.g. behaviour problems, low self esteem, trouble with social skills and developing relationships. This is for two four week long programmes modelled around adventure based learning and the use of the Papanui Youth Centre climbing wall. The programme focuses on goal setting, team work, communication, trust and positive engagement with their peers and adults.

The New Zealand Playcentre Federation formed as a national organisation in 1948 by providing parent education, equipment and facilities for quality early childhood education. Playcentre families receive a unique early childhood experience with opportunities for whanau/parents and children to learn together. This is achieved by offering:

- half day sessions for children of mixed age groupings
- a variety of self selected play activities and comprehensive quality equipment
- an accessible, flexible field-based education programme at minimal cost
- parenting skills and confidence in parenting

The Shirley Playcentre has been operating since 1963. The catchment for the playcentre is predominantly families form Shirley.
