#### PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2007/08 Youth Development Fund.

#### EXECUTIVE SUMMARY

- 2. Funding is being sought by Chloe Becker, a 16 year old student from Blighs Road, Strowan.
- 3. Chloe has been selected to go on a AFS student exchange programme to Switzerland in February 2008 for a 12 month period.
- 4. This exchange will require Chloe to immerse herself fully into the local culture, live with a host family, and attend a local high school as a full-time student.
- 5. This is the first time the applicant has approached the Board for funding support.

## FINANCIAL IMPLICATIONS

- 6. There are no legal issues to be considered.
- 7. The student exchange is organised through AFS Intercultural Programme and costs each student \$10,950. This cost includes all travel expenses, host family recruitment and support, and school fees. Chloe will also require an additional \$5,000 for incidentals, school trips, and other daily expenses throughout the year.
- 8. Chloe works part-time on Saturdays, Thursday evenings, and during holidays. This has enabled her to contribute financially towards the cost of the exchange. Her parents are both paying a half share of the AFS fee and Chloe is seeking \$500 from the Board towards her living expenses.

#### PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2007/08 Youth Development Scheme.

## **EXECUTIVE SUMMARY**

- 2. The applicant, Nicholas Taylor, is 24 years old and lives in the Bishopdale area.
- 3. Nicholas has been selected to participant in a seven week "Ship For World Youth" sailing voyage. There are 14 countries participating in the voyage which aims to foster mutual understanding between youth from different cultures.
- 4. The programme has been operating for 20 years and is organised and funded by the Japanese government. Whilst on the voyage Nicholas will be studying cross cultural understanding as depicted through the media and will also be presenting a paper on New Zealand culture. The ship sails from Tokoyo to Muscat (Oman) then on to India. Participants will be involved in youth activities in the various ports visited during the voyage.
- 5. Nicholas is in paid employment and is also a volunteer youth leader. To be considered for the programme Nicholas was required to apply to the Ministry of Youth Development who then selected ten young people from New Zealand. He is the only South Island representative.

# FINANCIAL IMPLICATIONS

6. The cost per person to participate in the programme is \$40,000 which is fully funded by the Japanese government, however Nicholas will incur the following expenses with this trip.
