PURPOSE OF REPORT

1. The purpose of this report is to seek Community Board approval for an application for funding from its 2007/08 Youth Development Fund.

EXECUTIVE SUMMARY

- 2. Funding is being sought by Jonathan Manu Broman, a 22 year old who lives in Riccarton, towards costs associated with a Judo competition in Canberra in mid-February 2008. Jonathon has been doing Judo for 13 years, has won the national competition a number of times, and represented New Zealand similarly on a number of occasions. He has also successfully competed in a number of international competitions.
- 3. Jonathon brings back what he gains from his experiences at out of town tournaments to his club and region. Jonathan helps to coach juniors weekly at his local club. His medium term objective is to attend the Olympics.

FINANCIAL IMPLICATIONS

4. The following outlines budgetary requirements for Jonathon's trip to Canberra:

- 5. Jonathon has already saved the \$672 for Airfare and Food/Accommodation/Petrol, and is requesting the funding of \$850 for the two Gi's. Jonathon has outgrown his current Gi's and will pass them on to other Judo competitors once he has acquired new ones. The Gi's will also allow Jonathon to participate in other upcoming events such as the National Training Camp in Auckland in February 2008, and the Oceania competition in Christchurch in March 2008.
- 6. Jonathon has previously applied to the Scotswood Trust, the Southern Trust, and the Riccarton Youth Trust for funding, but is not eligible to receive funding from those organisations.
- 7. Jonathon received \$500 from this fund in 2006 to attend a tournament. Given this, staff are recommending that the Board award a lower than average amount to this applicant in this instance.
