PURPOSE OF REPORT

1. The purpose of this report is to provide information about the applicants who have applied for funding for Neighbourhood Week to assist the Community Board with its decisions about the allocation of that funding.

EXECUTIVE SUMMARY

- 2. Neighbourhood Week is a dedicated week in which individuals and groups are encouraged to run a neighbourhood event to get to know one another better. This year Neighbourhood Week is being held from 1 9 November 2008. Applications for funding closed on 5 September 2008. This funding is seen as a subsidy to small, local events.
- 3. Local community groups, including residents' associations and neighbourhood support groups were sent information in August 2008 inviting them to apply for the Neighbourhood Week Funding that has been set aside by the Community Board.
- 4. Thirty-four applications for funding have been received and all applicants meet the set criteria and are worthy applicants.
- 5. Staff have assessed the applications and made recommendations for the allocation of funding. In doing this, staff have considered the nature of the event, the amount that is being applied for, the number of people expected to be at the event and the need for any payment to be of a 'significant' amount.
- 6. Funding requests totalled \$5,699, for the \$3,750 allocated by the Board. Given that all applicants meet the criteria, a per-head allocation (\$2.00) approach was first applied with a minimum of \$50.00 and a maximum of \$200.00 to ensure all applicants could be funded.
- 7. A matrix with application details and options is attached to this report as **attachment 2**. Also attached is a memorandum from staff (**attachment 1**) with details of a late application received and the Committee is asked to decide whether or not to consider this application.

FINANCIAL IMPLICATIONS

8. The Board has set aside \$3,750 from the Strengthening Communities Fund to assist individuals and groups to run Neighbourhood Week events. It is not the intention of this funding to totally fund events and those applying for funding are expected to partially resource their events themselves, either financially or through supply of materials.

Further to my Staff Report and Matrix in respect of Neighbourhood Week Funding, please find attached a late application for funding (\$90.00), received from Ellen Gay Withers on Wednesday 1 October 2008.

Ms Withers phoned our office on Monday 29 September to advise she had just returned from a business trip overseas to find she had missed the closing date for Neighbourhood Week Funding applications (5 September). She had been mailed information about Neighbourhood Week on the basis that she is a previous recipient of such funds. She was disappointed to miss the deadline and was keen for the Committee to give consideration to her application. Ms Withers expressed on the phone that she is the only one in the street who is prepared to plan and organise the event and without the funding the planned neighbourhood get-together at the bowling club on Donald Street would not go ahead.

An application form was posted to her on the understanding it would be presented to the Community Services Committee for consideration as a late application. Note, the application has not been included in the Matrix and approval of her application, or part thereof, increases the total amount of applications over and above the \$3,750 allocated for this event. Approval of the late application would either require a reduction in other recommendations or an allocation of funds from the Board's Discretionary Response Fund. Another possibility is that receipts received after the events may not total the amounts allocated and therefore there may be some monies remaining from which this application could be funded – naturally there is a risk associated with this approach.

Neighbourhood Week funds have been allocated for a get-together at the St Albans – Merivale Bowling Club on Donald Street on two previous occasions:

2007: Application from Gay Withers 1 Donald Place for \$90

Claimed \$90.00 (58 attendees)

2005 Application from Gay Withers, transferred to St Albans - Merivale Bowling Club (contact person

Alison Big), 5 Donald Place for \$30.00

Claimed \$30.00 (14 attendees)

PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Burnside Transformation Trust from the Community Board's 2008/09 Discretionary Response Fund.

EXECUTIVE SUMMARY

- 2. The Burnside Transformation Trust is seeking funding of \$2,000 to stage the annual Community Carols event at the Kendall School hall. This has been an annual event since 1972, when it was initiated by the Burnside Residents' Group.
- 3. In 2003 the Burnside Transformation Trust was formed comprising of St Timothy's and Burnside Elim Churches. The Trust assisted in the organisation of the event that year and in 2004 took over management of the event with members of Burnside Residents' Group joining the organising committee.
- 4. The aim of the event is to bring the local community together to celebrate the spirit of Christmas in an informal, neutral setting. The organising committee are all voluntary and committed to continuing the tradition of this local annual event.
