- 1. The purpose of this report is to present a request for funding from Annabelle Brown to the Fendalton/Waimairi Community Board from its 2008/09 Youth Development Scheme.
- 2. The request is for financial support towards the cost of participating in an AFS Intercultural Exchange to Italy.
- There is currently a balance of \$3,400 remaining in the Board's Youth Development Scheme.

EXECUTIVE SUMMARY

- 4. Annabelle Brown is a 17 year old student living in Bryndwr. She is currently in Year 13 at Burnside High School.
- Annabelle has been selected to take part in an AFS exchange programme to study in Italy for one year. The AFS Student Exchange programme aims to give students the chance to experience a different culture, lifestyle, and school system, while helping to build blocks for future career choices or pathways. This exchange will require Annabelle to fully immerse herself into the local culture, live with a host family, and attend a local high school as a full-time student.
- 6. Annabelle is extremely excited about this opportunity and is looking forward to the challenge of stepping outside her comfort zone and experiencing new things. She has a strong passion for the arts, particularly design and photography, so the opportunity to study in Italy is ideal.
- 7. Annabelle has shown a huge commitment to raising the funds to participate in the programme including having 3 part-time jobs during the school holidays to go towards the course fees. She also applied for an AFS scholarship and has been successful. This scholarship reduces her course fee by \$7,500.

PURPOSE OF REPORT

- 1. The purpose of this report is to present a request for funding from three Cobham Intermediate students to the Fendalton/Waimairi Community Board from its 2008/09 Youth Development Scheme to attend the International Future Problem Solving Conference.
- 2. The applicants are:
 - (i) Daniel Coats, 12 year old student living in Bryndwr.
 - (ii) Brendan Chin, 12 year old student living in Fendalton.
 - (iii) Chun-Tang Pai, 12 year old student living in Burnside.
- 3. There is currently a balance of \$3,400 remaining in the Board's Youth Development Scheme.

EXECUTIVE SUMMARY

- 4. The above students from Cobham Intermediate have been selected to represent New Zealand at the prestigious International Future Problem Solving Conference. This conference is to be held at the Michigan State University at the end of May 2009. This conference will be attended by over two thousand of the brightest young minds from America, the Asia/Pacific region, South Africa and other parts of the world so it is a unique experience for these young New Zealanders to interact with and compete against such an outstanding group of young people and to experience American college life.
- 5. The Future Problem Solving Programme arms students with problem solving skills, develops positive views of the future, and teaches them to work in teams to grapple with many complex world issues. Recent research in Australia has shown that over 80% of Future Problem Solving students go on to higher levels of tertiary education such as medicine, law and scientific research.
- 6. The programme encourages students to carry out in-depth research, to think creatively and critically, to apply ethical thinking skills and to work as part of a team. Examples of topics this team have already covered include: Body Enhancement; Simulation Technology; Deforestation; and The Risk Averse Society. The topic for the International Conference is Pandemic.
- 7. Cobham Intermediate are undertaking various fundraising activities to raise money towards the cost of sending the team over to America. The team consists of two adults and five students. The school also intend to apply for financial support from the Southern Trust, Mainland Foundation and the First Sovereign Trust.

The applicants have been selected for the U13 Te Waipounamu Netball Team (South Island) to compete in the Aotearoa Maori Netball Oranga Healthy Lifestyle Tournament being held in Hamilton in April this year. This tournament brings together 11 regions throughout New Zealand, with five age groups per region and attracts approximately 4,000 players.
- 4. Hayley is a member of the Merlins Netball club and has been chosen to captain the Te Waipounamu team. She is also a junior umpire plus a mentor for the younger players and has represented Canterbury in age group basketball.
- 5. Kelsey plays for the Papanui Tigers Netball Club and also plays indoor summer netball.
- 6. To gain selection for the team the girls were required to attend two trials held in Dunedin in November and December last year. Following selection a total of five team trainings were held in Oamaru. The families advise that due to travel commitments required for the girls to attend training it has been difficult to carry out any major fundraising activities, however they have organised a sponsored swim-a-thon and goal-athon which raised \$150 each for the local players.

PURPOSE OF REPORT

- 1. The purpose of this report is to present a request for funding of \$4,370 from the Burnside Primary School Board of Trustees to the Fendalton/Waimairi Community Board from its 2008/09 Discretionary Response Fund.
- 2. The request is for \$4,370 towards the cost of establishing an International Garden.
- 3. There is currently a balance of \$18,534 remaining in the Board's 2008/09 Discretionary Response Fund.

EXECUTIVE SUMMARY

- 4. Burnside Primary School is located on Memorial Avenue, Burnside and has a roll of 250 children. It caters for students from a wide range of nationalities and cultures from Years 1 to 6. New Zealand European students make up 45% of the school roll, followed by 22% Asian students, 11% Maori students, and the remaining 22% are from other various ethnicities.
- 5. As a way of recognising and celebrating the cultural diversity of the school, they have set aside an area of 280 square metres at the entrance to the school to develop an 'International Garden'.
- 6. A circular area will be divided into five continents, Africa, Asia, America, Europe and Oceania, to represent the cultural identities of their students.
- 7. The central focus of this area will have New Zealand native plantings. The native area leads towards the school entrance forming a Koru. The New Zealand section will include plants used by early Maori for food, medicine and fibres. It will also include native plants that originally grew in the Burnside area.
- 8. The other continents will be planted with plants of origin from that continent.
- 9. The garden will also include five totem poles that will represent the five continents. Fencing around the garden will be used to display children's art work.
- 10. The children will be involved in the following ways:
 - the planting and ongoing care and maintenance of the garden
 - designing and making stepping stones to represent the continents
 - creating designs on the five totem poles
- 11. This project will have a number of benefits to the students involved. It will teach the children basic gardening skills along with the responsibility of maintaining the garden. The nature of the garden will also provide opportunities for discussion and learning about different cultures. It will also create opportunities for the wider school community to be involved in the garden and this may result in greater community participation in other school activities.
