#### PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Community Board's 2009/10 Youth Development Scheme.

#### **EXECUTIVE SUMMARY**

- 2. The applicant, Phillip David Malzard, is an 18 year old who lives in Halswell and is seeking Community Board support to travel to Palmerston North to compete in Basketball at the Special Olympics Summer Games. This trip will take place from 2 6 December 2009.
- 3. Phillip has been playing basketball for three years on a regular basis for his school, Allenvale, which has been of real benefit to his personal development and growth. This year the school made a successful application for their team to be accepted into the Summer Games which is only offered every four years.
- 4. This trip will be of personal benefit to Phillip as it provides opportunities for social skills, coping with a big atmosphere as well as having fun. The event promotes healthy lifestyle and the importance of fitness and health and will also help raise the public awareness and promote a positive view on students with a disability.
- 5. Phillip is also learning guitar, which he is committed to and is progressing well at. Phillip is working with his school towards independence and after leaving school next year is hoping to secure full time work as well.
- 6. The team have been actively fundraising for their trip selling chocolates and running sausage sizzles and the family has contributed \$300 of their savings towards his expenses as well.

#### PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Community Board's 2009/10 Youth Development Scheme.

#### **EXECUTIVE SUMMARY**

- The applicant, Ali Nazari, is a 16 year old who lives in Hei Hei and is seeking Community Board support to travel to Auckland with the Burnside High School First 11 Football team for the New Zealand Secondary Schools' Football Premier Tournament. The trip will take place from 30 August – 4 September 2009.
- 3. Ali has represented Canterbury in Football from the age of 11 and is currently involved in three different football teams, both indoor and outdoor. Ali trains four times a week as well as playing on the weekend and shows a high commitment to his sport.
- 4. Ali has recently won a scholarship for the Sporting Futures Programme, where he is receiving high level coaching and is hoping to improve his skills and progress to a higher level following this programme. Ali's goal is to be selected again for Canterbury and South Island teams and also aims for National selection.
- 5. Ali comes from a limited income family, from which several members are involved in sport and he would appreciate any financial assistance from the Community Board.
