10. CONFIRMATION OF MEETING MINUTES – BOARD MEETING OF 16 DECEMBER 2008

The Board **resolved** that the minutes of its ordinary meeting of 16 December 2008, be confirmed.

11. WORKS, TRAFFIC AND ENVIRONMENT COMMITTEE REPORT – MEETING OF 2 FEBRUARY 2009

The Committee Chairperson presented the report and summarised the deputations and debate regarding the Proposed Merivale Parking Plan conducted at the meeting on 2 February 2009. The Chairperson then moved the Committee recommendations.

The Board was advised that it had the approval of the relevant Council General Managers, as required under the Register of Delegations, to make a final decision on the proposed parking plan resolutions that involve Papanui Road, which is an arterial road, and St Albans Street, which is a collector road. Decisions regarding these two roads would otherwise require Council approval. It was considered that the measures imposed on these two roads under the parking plan have only a local impact and do not have city-wide effects.

11. Cont'd

The Board received the report of its Works, Traffic and Environment Committee meeting of 2 February 2009 specifically in regard to the Proposed Merivale Parking Plan and **resolved** to approve the following:

(a) **Merivale North Parking Plan: Restrictions**

- (i) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Leinster Road commencing at a point 17 metres north east of its intersection with Allister Avenue and extending in a north easterly direction for a distance of 63 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (ii) That the stopping of vehicles be prohibited (at any time) on the north west side of Leinster Road commencing at a point 80 metres north east of its intersection with Allister Ave and extending in a north easterly direction for a distance of 43 metres.
- (iii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Leinster Road commencing at a point 123 metres north east of its intersection with Allister Avenue and extending in a north easterly direction for a distance of 120 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (iv) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Aikmans Road commencing at a point 61 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 27 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (v) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Aikmans Road commencing at a point 126 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 58 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (vi) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north east side of Akela Street commencing at a point 16 metres south east of its intersection with Aikmans Road and extending in a south easterly direction for a distance of 18 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (vii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north east side of Akela Street commencing at a point 38 metres south east of its intersection with Aikmans Road and extending in a south easterly direction for a distance of 83 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (viii) That the stopping of vehicles be prohibited (at any time) on the north east side of Stirling Street commencing at its intersection with Office Road and extending in a north westerly direction for a distance of 11 metres.
- (ix) That the stopping of vehicles be prohibited (at any time) on the north west side of Office Road commencing at its intersection with Stirling Street and extending in a north easterly direction for a distance of 15 metres.
- (x) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Office Road commencing at a point 15 metres north east of its intersection with Stirling Street and extending in a north easterly direction for a distance of 169 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xi) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Office Road commencing at a point 150 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 30 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.

11. Cont'd

- (xii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Office Road commencing at a point 284 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 54 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xiii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south west side of Winchester Street commencing at a point 10 metres north west of its intersection with Rugby Street and extending in a north westerly direction for a distance of 55 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xiv) That the stopping of vehicles be prohibited (at any time) on the south west side of Papanui Road commencing at its intersection with Rugby Street and extending in a north westerly direction for a distance of 4 metres.
- (xv) That the stopping of vehicles be prohibited (at any time) on the north west side of Rugby Street commencing at its intersection with Papanui Road and extending in a south westerly direction for a distance of 10 metres.
- (xvi) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Rugby Street commencing at a point 10 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 29 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xvii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Rugby Street commencing at a point 80 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 262 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xviii) That the stopping of vehicles currently prohibited (at any time) on the north west side of Murray Place commencing at its intersection with Papanui Road and extending in a north easterly direction for a distance of 14 metres, be revoked.
- (xix) That the stopping of vehicles be prohibited (at any time) on the north west side of Murray Place commencing at its intersection with Papanui Road and extending in a north easterly direction for a distance of 26 metres.
- (xx) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Murray Place commencing at a point 26 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 126 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xxi) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south west side of Murray Place commencing at a point 16 metres north west of its intersection with McDougall Avenue and extending in a north westerly direction for a distance of 85 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xxii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of McDougall Avenue commencing at a point 15 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 179 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xxiii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Mansfield Avenue commencing at a point 66 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 23 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.

11. Cont'd

- (xxiv) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Mansfield Avenue commencing at a point 117 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 98 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (xxv) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Mansfield Avenue commencing at a point 238 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 9 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.

(b) **Papanui Road Bus Priority Project: Restrictions**

- (i) That the parking of vehicles be restricted to a maximum period of 60 minutes on the south west side of Papanui Road commencing at a point 42 metres north west of its intersection with Leinster Road and extending in a north westerly direction for a distance of 42 metres. This restriction is to apply from 8.00am to 3.00pm Monday to Friday and from 8.00am to 6.00pm Saturday and Sunday.
- (ii) That the stopping of vehicles currently prohibited (at any time) on the south west side of Papanui Road commencing at its intersection with Heaton Street and extending in a south easterly direction for a distance of 76 metres, be revoked.
- (iii) That the stopping of vehicles be prohibited (at any time) on the south west side of Papanui Road commencing at its intersection with Heaton Street and extending in a south easterly direction for a distance of 81 metres.
- (iv) That the parking of vehicles be restricted to a maximum period of 60 minutes on the north east side of Papanui Road commencing at a point 15 metres south east of its intersection with Murray Place and extending in a south easterly direction for a distance of 44 metres.
- (v) That the stopping of vehicles currently prohibited (at any time) on the north east side of Papanui Road commencing at its intersection with McDougall Avenue and extending in a north westerly direction for a distance of 10 metres, be revoked.
- (vi) That the stopping of vehicles be prohibited (at any time) on the north east side of Papanui Road commencing at its intersection with McDougall Avenue and extending in a north westerly direction for a distance of 17 metres.
- (vii) That the parking of vehicles be restricted to a maximum period of 5 minutes on the south west side of Papanui Road commencing at a point 6 metres north west of its intersection with Office Road and extending in a north westerly direction for a distance of 12 metres.
- (viii) That the parking of vehicles be restricted to a maximum period of 30 minutes on the north west side of Leinster Road commencing at a point 11 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 194 metres.
- (ix) That the parking of vehicles be restricted to a maximum period of 30 minutes on the south east side of Leinster Road commencing at a point 11 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 217 metres.
- (x) That the parking of vehicles be restricted to a maximum period of 30 minutes on the south east side of Aikmans Road commencing at a point 127 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 66 metres.

11. Cont'd

- (xi) That the parking of vehicles be restricted to a maximum period of 30 minutes on the north west side of Office Road commencing at a point 33 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 78 metres.
- (xii) That the parking of vehicles be restricted to a maximum period of 30 minutes on the north west side of Office Road commencing at a point 134 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 33 metres.
- (xiii) That the parking of vehicles be restricted to a maximum period of 30 minutes on the north west side of St Albans Street commencing at a point 57 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 64 metres.
- (xiv) That the parking of vehicles be restricted to a maximum period of 30 minutes on the north west side of St Albans Street commencing at a point 146 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 16 metres.
- (xv) That the parking of vehicles be restricted to a maximum period of 30 minutes on the south east side of St Albans Street commencing at a point 32 metres north east of its intersection with Papanui Road and extending in a north easterly direction for a distance of 125 metres.
- (xvi) That the parking of vehicles be restricted to a maximum period of 60 minutes on the south east side of St Albans Street commencing at a point 23 metres north east of its intersection with Devonport Lane and extending in a north easterly direction for a distance of 34 metres.
- (c) That a separate detailed study be undertaken on Heaton Street between Allister Avenue and Papanui Road, to include Allister Avenue and Circuit Street. This study should consider changes to parking restrictions and general traffic management including possible introduction of cycle lanes and changes to nearby bus stop locations. The study should focus on school safety, parking demand and changing parking demands due to surrounding activities, support of the Proposed Merivale Parking Plan and any changing parking demands on Allister Avenue and Circuit Street.
- (d) That a further report be brought back to the Board with respect to Leinster Road, specifically in regard to parking around Elmwood School.
- (e) That P120 parking restrictions (11.00am to 3.00pm, Monday to Friday) be approved for both sides of Church Lane, except for the area covered by the existing P5 restriction on the south east side, as detailed in the following specific resolutions:
 - (i) That the stopping of vehicles be prohibited at any time on the south west side of Papanui Road commencing from its intersection with Church Lane and extending in a south easterly direction for a distance of 15 metres.
 - (ii) That the stopping of vehicles be prohibited at any time on the south east side of Church Lane commencing from its intersection with Papanui Road and extending in a south westerly direction for a distance of 15 metres.

11. Cont'd

- (iii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Church Lane commencing at a point 15 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 14 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (iv) That the stopping of vehicles be prohibited at any time on the south east side of Church Lane commencing at a point 29 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 6 metres.
- (v) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Church Lane commencing at a point 35 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 45 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (vi) That the parking of vehicles be restricted to a maximum period of 5 minutes (at any time) on the south east side of Church Lane commencing at a point 80 metres from its intersection with Papanui Road and extending in a south westerly direction for a distance of 27 metres.
- (vii) That the parking of vehicles be restricted to a maximum period of 120 minutes on the south east side of Church Lane commencing at a point 107 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 127 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (viii) That the stopping of vehicles be prohibited at any time around the head of the cul-de-sac of Church Lane commencing on the south east side of Church Lane at a point 234 metres from its intersection with Papanui Road and extending in a clockwise direction for a distance of 57 metres finishing on the north west side of Church Lane.
- (ix) That the parking of vehicles be restricted to a maximum period of 120 minutes on the north west side of Church Lane commencing at a point 15 metres south west of its intersection with Papanui Road and extending in a south westerly direction for a distance of 216 metres. This restriction is to apply from 11.00am to 3.00pm, Monday to Friday.
- (x) That the stopping of vehicles be prohibited at any time on the north west side of Church Lane commencing at its intersection with Papanui Road and extending in a south westerly direction for a distance of 15 metres.
- (xi) That the stopping of vehicles be prohibited at any time on the south west side of Papanui Road commencing at its intersection with Church Lane and extending in a north westerly direction for a distance of 15 metres.

(Note: Faimeh Burke requested that her vote in opposition to the implementation of parking restrictions detailed within the Proposed Merivale Parking Plan (clauses (a) and (b) above) be recorded, but noted that she supported the resolutions relating to Church Lane, Heaton Street and Leinster Road (clauses (c) to (e) above).

The Board noted that as part of the bus priority project staff would in 12 months' time be monitoring and reviewing the parking restrictions specifically relating to the bus priority project. Following further discussion with the Board, staff agreed to include all the parking restrictions incorporated in the Proposed Merivale Parking Plan as part of that monitoring and review process.
