#### PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Board's 2008/09 Youth Development Scheme.

#### EXECUTIVE SUMMARY

2. The applicant is Olivia Carswell-Moyna, a 12 year old Kirkwood Intermediate student living in Bryndwr.
3. Olivia, along with 14 other students from Kirkwood Intermediate, has been invited to participate in a cultural exchange with Christchurch's Sister City, Songpa-Gu in Korea, from 15 to 25 February 2009.
4. In 2008 Kirkwood Intermediate hosted 15 students from Songpa-Gu. The school is contributing \$7,000 towards the group's costs and has submitted a funding application to the Southern Trust. The outcome of this application is as yet unknown.
