Dear Sir/Madam

I wish to discuss the following matter with you. I am in my mid 50's, hence you will realise the age of my mother. My mother lives in a two bedroom townhouse at 23 Kedleston Drive where she has lived (previously with my father who died 2 years ago) for a number of years.

A tree on the council berm is a cause of concern. This tree has progressively gotten bigger over the years and the pods it drops at this time of the year have gotten bigger (up to 30cm in length and 40mm in width) and there are naturally more of them (hundreds). The tree would easily be over 15 metres high now. In the past my father always undertook the job of removing the pods from the lawn (which tend to kill the lawn if left) and swept and cleaned these up. My Mum is finding this an increasing amount of work now and it isn't good for her health to be outside in all weathers at this time of the year cleaning up these pods, to stop them blocking spoutings and drains, blowing around the street and killing her lawn. She takes pride in her property and does have manageable trees and a lovely garden.

When housing consent was given to 23 Kedleston Drive, I would think it would have been envisaged that only 1 or 2 people would live in this size home, hence the type of people there would be retired and cutting back on work due to age or health. The type of tree planted would probably not have been envisaged to grow the way it has and develop into a nuisance for residents. I would have thought this type of tree was more suitable for a park or similar.

Is there any way you could consider removing it and planting something more resident friendly?

Naturally, you are welcome to view this tree and maybe consider whether you would like it outside your aged parents' home for them to tend to its mess.

PURPOSE OF REPORT

1. The purpose of this report is to provide the Board with the opportunity to consider the funding applications it wishes to nominate as Key Local Projects (KLPs) for 2009/10.

EXECUTIVE SUMMARY

- 2. As part of the Strengthening Communities Grants Funding Programme, each Board may nominate Key Local Projects in its area that are put forward to the Metropolitan Funding Committee for consideration for metropolitan funding.
- 3. The Metropolitan Funding Committee will make KLP decisions based on affordability and the following priorities:
 - Strengthening Communities Strategy Principles and Goals;
 - Funding outcomes and priorities as set out in Strengthening Communities Strategy;
 - Alignment to local Community Board objectives;

AND

- Projects deliver benefits to the city outside of the local Board area;
- Key community issues contemplated under Goal 2 of the Strengthening Communities Strategy.
- 4. In addition, staff recommendations for KLPs are also based on whether the project meets the following criteria:
 - The organisation undertaking the project has a proven track record with Council in providing a high quality level of service;
 - Significantly contributes towards the Council's Funding Outcomes and Priorities;
 - Demonstrates leadership and innovation;
 - Demonstrates best-practice and collaboration.
- 5. At the Fendalton/Waimairi Community Board workshop held on 6 May 2009, staff recommended that no projects be nominated by the Board as Key Local Projects for the 2009/10 funding round.

Timeline and Process

- 6. The KLPs as approved by the Board will be put forward to the Metropolitan Strengthening Communities Funding Committee for consideration at its meeting on 20 July 2009.
- 7. Any recommended KLPs will be considered for a two year funding period to ensure that all KLPs are kept in line with the three year KLP funding cycle which commenced in July 2008.

FINANCIAL IMPLICATIONS

- 8. In 2008/09 each Christchurch City Community board had \$280,000 to allocate in its Strengthening Communities Fund. Akaroa/Wairewa and Lyttleton/Mt Herbert had \$35,000 and \$45,000 respectively available for their allocation.
- 9. The finalised 2009/2010 grants funding allocation amounts are currently awaiting sign off through the Long Term Council Community Plan (LTCCP) processes.

10. If recommended KLPs do not receive funding at a Metropolitan level, they will be returned to the Board for consideration with its remaining Strengthening Communities applications.

Do the Recommendations of this Report Align with 2006-16 LTCCP budgets?

11. Yes.

12. Yes. Community Board funding decisions are made under delegated authority from the Council.

15. No external consultation needs to be undertaken, although staff have discussed funding applications with those groups that have submitted the applications.

STAFF RECOMMENDATION

It is recommended that the Fendalton/Waimairi Community Board do not nominate any projects to be considered as Key Local Projects for the 2009/10 Strengthening Communities Fund.

BACKGROUND (THE ISSUES)

- 16. The Council adopted the Strengthening Communities Strategy on 12 July 2007. The Strategy incorporated the Community Group Grants Review which provided the framework, principles and funding outcomes for the new Strengthening Communities Grants Funding Programme. This programme replaces the Project and Discretionary Funding process as previously used by the community boards.
- 17. Council staff reviewed the funding programme following the 2008/09 funding year and consulted all interested parties on the successes and failures of the process. As a result of this review, some changes were implemented. The full report detailing these changes can be viewed as part of the Council agenda for its meeting on 27 November 2008.
- 18. The Strengthening Communities Grants Funding Programme comprises four funding schemes, which supersede all previous community group grant schemes, sub-schemes and categories. The schemes are:
 - (a) Strengthening Communities Fund
 - (b) Small Grants Fund
 - (c) Discretionary Response Fund
 - (d) Community Organisations Loan Scheme
- 19. The funding schemes enable Council and its community boards to support and provide leverage opportunities for not-for-profit, community focused groups seeking funding in support of their community endeavours.
- 20. Each Board may nominate Key Local Projects (KLPs) in its area that are put forward to the Metropolitan Funding Committee for consideration for metropolitan funding.
- 21. The agreed process to determine if a "local" funding application should be processed as a KLP was detailed in the report adopted by Council on 4 October, 2007.
- 22. The Metropolitan Funding Committee will make KLP decisions based on affordability and the following priorities:
 - Strengthening Communities Strategy Principles and Goals;
 - Funding outcomes and priorities as set out in Strengthening Communities Strategy;
 - Alignment to local Community Board objectives;

AND

- Projects deliver benefits to the city outside of the local Board area;
- Key community issues contemplated under Goal 2 of the Strengthening Communities Strategy.
- 23. The process for considering KLPs is as follows:
 - i. Community Boards nominate and prioritise their KLPs and make a recommendation to the Metropolitan Funding Committee.
 - ii. The Metropolitan Funding Committee makes decisions on Board recommended KLPs.
 - iii. Successful KLPs are allocated funding from the Metropolitan Strengthening Communities Fund.
 - iv. Unsuccessful KLPs are returned to the Community Board for consideration under the local Strengthening Communities Fund.

- 24. Community Boards are advised that where candidates for KLP funding consideration are successful in receiving funding from the Metropolitan Funding Committee, then there can be no further call on the Board for that project.
- 25. This is also the case, where a successful candidate is funded to a lower level than has been recommended by the board. This reflects the "funding constraints" criteria agreed by Council in Appendix F of the October 4, 2007 report which states that "groups receiving funding at a Metropolitan level may only receive local level funding if the project is specifically local and no portion of it has been funded at the Metropolitan level".
- 26. The following table lists all of the organisations that were funded as KLPs in the 2008/09 funding year.

PURPOSE OF REPORT

The purpose of this report is to submit the following outcomes of the Works, Traffic and Environment Committee meeting held on Monday 27 April 2009 at 8.00am.

The meeting was attended by Cheryl Colley (Chairperson), Sally Buck, Faimeh Burke, Val Carter, Jamie Gough, Mike Wall and Andrew Yoon.

An apology for early departure was received and accepted from Faimeh Burke who retired at 9.30am and was absent for part of clauses 12 and 13, which were taken together.

1. DEPUTATIONS BY APPOINTMENT

1.1 John Bennett – Hartley Avenue Street Renewal

John Bennett, a resident of Hartley Avenue, was in attendance and spoke to the Hartley Avenue/Hawthorne Street renewal project. Mr Bennett raised concerns regarding the number of street treatments along Hartley Avenue, the selection of street trees, stating a preference for deciduous trees, and the narrow nature of the intersection of Normans Road and Hartley Avenue.

The Chairperson thanked Mr Bennett for his presentation.

1.2 George and Suzie Gould – Desmond Street

George and Suzie Gould, residents of Desmond Street, were in attendance to request that the choice of trees proposed for Desmond Street be reconsidered and that Liquidambar trees rather than Maple trees be planted on both sides of the street.

Mr and Mrs Gould commended the Project Manager Kerry O'Neill on his work on this project noting that he had been a great ambassador for the Council.

Mr Gould also commented on the heritage value of Helmores Lane bridge and recommended that the Council consider stopping traffic from turning into Helmores Lane from Harper Avenue to improve safety around the bridge area. The Committee noted that this was outside the scope of this report and actually in the Hagley/Ferrymead Ward but members would give the proposal further consideration.

The Chairperson thanked Mr and Mrs Gould for their interest in their neighbourhood and their presentation at the meeting.

2. CORRESPONDENCE

2.1 Letter from St James Church, Harewood

A letter was received from the St James Church Committee outlining concerns regarding the road edge and grass verge outside the church on Harewood Road.

The Committee **received** the correspondence and requested that staff investigate the matter and provide a response to a subsequent Works, Traffic and Environment Committee meeting.

3. NORMANS ROAD - PROPOSED NO STOPPING RESTRICTION

The Committee's recommendation was sought to approve that the stopping of vehicles be prohibited at any time at the intersection of Normans Road, Hartley Avenue and St Andrews Square.

Committee Recommendation:

That the Board approve:

- (a) That the stopping of vehicles be prohibited at any time on the North side of Normans Road commencing at its intersection with Hartley Avenue and extending in a westerly direction for a distance of 15 metres.
- (b) That the stopping of vehicles be prohibited at any time on the North side of Normans Road commencing at its intersection with Hartley Avenue and extending in an easterly direction for a distance of 11 metres.
- (c) That the stopping of vehicles be prohibited at any time on the South side of Normans Road commencing at its intersection with St Andrews Square and extending in a westerly direction for a distance of 9 metres.
- (d) That the stopping of vehicles be prohibited at any time on the South side of Normans Road commencing at its intersection with St Andrews Square and extending in an easterly direction for a distance of 12 metres.
- (e) That the stopping of vehicles be prohibited at any time on the West side of the eastern segment of St Andrews Square commencing at its intersection with Normans Road and extending in a southerly direction for a distance of 18 metres.
- (f) That the stopping of vehicles be prohibited at any time on the East side of the eastern segment of St Andrews Square commencing at its intersection with Normans Road and extending in a southerly direction for a distance of 15 metres.
- (g) That the stopping of vehicles be prohibited at any time on the West side of Hartley Avenue commencing at its intersection with Normans Road and extending in a northerly direction for a distance of 15 metres.
- (h) That the stopping of vehicles be prohibited at any time on the East side of Hartley Avenue commencing at its intersection with Normans Road and extending in a northerly direction for a distance of 17 metres.

4. HEWITTS ROAD - PROPOSED NO STOPPING RESTRICTION

The Committee's recommendation was sought to approve that the stopping of vehicles be prohibited at any time on a section of the west side of Hewitts Road.

Staff Recommendation:

It is recommended that the Fendalton/Waimairi Works, Traffic and Environment Committee recommends that the Board approves:

(a) That the parking of vehicles currently restricted to a maximum period of 120 minutes Monday to Friday (School days) on the west side of Hewitts Road commencing at a point 9 metres north of its intersection with Carlton Mill Road and extending in a northerly direction for a distance of 112 metres, be revoked.

- (b) Approve the following on Hewitts Road:
 - (i) That the stopping of vehicles be prohibited at any time on the west side of Hewitts Road commencing at a point 84 metres north of its intersection with Carlton Mill Road and extending in a northerly direction for a distance of 25 metres.
 - (ii) That the parking of vehicles be restricted to a maximum period of 120 minutes Monday to Friday (School days) on the west side of Hewitts road commencing at a point 9 metres north of its intersection with Carlton Mill Road and extending in a northerly direction for a distance of 75 metres.

Committee Recommendation:

- (a) That the Board make no changes to the existing parking restrictions in place in Hewitts Road.
- (b) That staff be asked to note when reviewing relevant City Plan provisions, that members have some concerns about a perceived narrowing of driveways across the city and the impacts this has on the roading network and access to properties.

In making recommendation (a) the Committee noted:

- Opposition to the proposal from some residents;
- Possible improvements that could be made to individual properties to help alleviate the concerns;
- Likely improvements resulting from the upcoming street renewal project; and
- Preference for a cautious approach considering that many other residents across the city
 with a similar situation may be encouraged to request no stopping restrictions for their
 streets should this request be approved.

5. WAIRAKEI ROAD - PROPOSED PARKING RESTRICTIONS

The Committee's recommendation was sought that the proposed traffic parking restrictions, consisting of minor amendments following the Wairakei Road upgrade project be approved.

Committee Recommendation:

That the Board approve the installation of the following parking restrictions to take effect following completion of Wairakei Road upgrade project:

(a) Revoke Existing No Stopping

Wairakei Road

- (i) That the existing no stopping be revoked on north side of Wairakei Road from 95 metres east of Westholme Street to 43 metres west of Manor Place, be revoked.
- (ii) That the existing no stopping be revoked on the south side of Wairakei Road from 75 metres east of Jeffreys Road to 48 metres west of Murdoch Street, be revoked.

Pitcairn Crescent

(i) That the existing no stopping resolutions on the north-west side of Pitcairn Crescent commencing at intersection with Wairakei Road and extending in a north-easterly direction for a distance of 13 metres, be revoked.

(ii) That the existing no stopping resolutions on the south-east side of Pitcairn Crescent commencing at its intersection with Wairakei Road and extending in a north-easterly direction for a distance of 15 metres, be revoked.

Rosewood Place

- (i) That the existing no stopping resolutions on the north-west side of Rosewood Place commencing at its intersection with Wairakei Road and extending in a north-easterly direction for a distance of 13 metres, be revoked.
- (ii) That the existing no stopping resolutions on the south-east side of Rosewood Place commencing at its intersection with Wairakei Road and extending in a north-easterly direction for a distance of 13 metres, be revoked.

Westholme Street

- (i) That the existing no stopping resolutions on the west side of Westholme Street commencing at its intersection with Wairakei Road and extending in a northerly direction for a distance of 17 metres, be revoked.
- (ii) That the existing no stopping resolutions on the east side of Westholme Street commencing at its intersection with Wairakei Road and extending in a northerly direction for a distance of 16 metres, be revoked.

Galway Avenue

- (i) That the existing no stopping resolutions on the south east side of Galway Avenue commencing at its intersection with Wairakei Road and extending in a south westerly direction for a distance of 16 metres, be revoked.
- (ii) That the existing no stopping resolutions on the north west side of Galway Avenue commencing at its intersection with Wairakei Road and extending in a south westerly direction for a distance of 19 metres, be revoked.

Chislehurst Place

- (i) That the existing no stopping resolutions on the south east side of Chislehurst Place commencing at its intersection with Wairakei Road and extending in a south westerly direction for a distance of 27 metres, be revoked.
- (ii) That the existing no stopping resolutions on the north west side of Chislehurst Place commencing at its intersection with Wairakei Road and extending in a south westerly direction for a distance of 19 metres, be revoked.

Ilam Road

- (i) That the existing no stopping resolutions on the south side of Ilam Road commencing at its intersection with Wairakei Road and extending in a westerly direction for a distance of 36 metres, be revoked.
- (ii) That the existing no stopping resolutions on the north side of Ilam Road commencing at its intersection with Wairakei Road and extending in a westerly direction for a distance of 36 metres, be revoked.

Manor Place

(i) That the existing no stopping resolutions on the western side of Manor Place commencing at its intersection with Wairakei Road and extending in a northerly direction for a distance of 15 metres, be revoked.

(ii) That the existing no stopping resolutions on the eastern side of Manor Place commencing at its intersection with Wairakei Road and extending in a northerly direction for a distance of 15 metres, be revoked.

Torquay Place

- (i) That the existing no stopping resolutions on the western side of Torquay Place commencing at its intersection with Wairakei Road and extending in a northerly direction for a distance of 12 metres, be revoked.

- (iv) That all existing no stopping resolutions on the north side of Brenchley Avenue from Urunga Avenue and extending 20 metres in an easterly direction, be revoked.
- (v) That all existing no stopping resolutions on the south side of Brenchley Avenue from Urunga Avenue and extending 20 metres in an easterly direction, be revoked.

New No Stopping

- (i) That the stopping of vehicles be prohibited at any time on the east side of Urunga Avenue commencing from its intersection with Halton Street and extending in a southerly direction for 14 metres.
- (ii) That the stopping of vehicles be prohibited at any time on the west side of Urunga Avenue commencing from its intersection with Halton Street and extending in a southerly direction for 14 metres.
- (iii) That the stopping of vehicles be prohibited at any time on the east side of Urunga Avenue commencing from its intersection with Normans Road and extending in a northerly direction for 16 metres.
- (iv) That the stopping of vehicles be prohibited at any time on the west side of Urunga Avenue commencing from its intersection with Normans Road and extending in a northerly direction for 17 metres.
- (v) That the stopping of vehicles be prohibited at any time on the east side of Urunga Avenue commencing 69 metres south of its intersection with Brenchley Avenue and extending in a southerly direction for 25 metres.

- (vi) That the stopping of vehicles be prohibited at any time on the west side of Urunga Avenue commencing 68 metres south of its intersection with Brenchley Avenue and extending in a southerly direction for 30 metres.
- (vii) That the stopping of vehicles be prohibited at any time on the east side of Urunga Avenue commencing from its intersection with Brenchley Avenue and extending in a southerly direction for 11 metres.
- (viii) That the stopping of vehicles be prohibited at any time on the east side of Urunga Avenue commencing from its intersection with Brenchley Avenue and extending in a northerly direction for 13 metres.

(a) Approve the Halton Street (Watford Street to Hartley Avenue section) plans, TP313301 and TP313201, as attached to the Committee agenda, for final design, tender and construction.

(b) Approve the following parking restrictions to take effect following completion of construction.

Remove Existing No Stopping

- (i) That all existing no stopping resolutions on the north side of Halton Street from Hartley Avenue to Watford Street, be revoked.
- (ii) That all existing no stopping resolutions on the south side of Halton Street from Hartley Avenue to Watford Street, be revoked.

New No Stopping

- (i) That the stopping of vehicles be prohibited at any time on the north side of Halton Street commencing at its intersection with Hartley Avenue and extending in an easterly direction for 12 metres.
- (ii) That the stopping of vehicles be prohibited at any time on the south side of Halton Street commencing at its intersection with Hartley Avenue and extending in an easterly direction for 12 metres.
- (iii) That the stopping of vehicles be prohibited at any time on the north side of Halton Street commencing 14 metres west of its intersection with Urunga Avenue and extending in an easterly direction for 37 metres.
- (iv) That the stopping of vehicles be prohibited at any time on the south side of Halton Street commencing at its intersection with Urunga Avenue and extending in a westerly direction for 17 metres.
- (v) That the stopping of vehicles be prohibited at any time on the south side of Halton Street commencing at its intersection with Urunga Avenue and extending in an easterly direction for 16 metres.
- (vi) That the stopping of vehicles be prohibited at any time on the north side of Halton Street commencing 98 metres east of its intersection with Urunga Avenue and extending in an easterly direction for 12 metres.
- (vii) That the stopping of vehicles be prohibited at any time on the south side of Halton Street commencing 93 metres east of its intersection with Urunga Avenue and extending in an easterly direction for 20 metres.

11. HARTLEY AVENUE/HAWTHORNE STREET - STREET RENEWAL IN THE WATFORD CLUSTER

The Committee's recommendation was sought for the Hartley Avenue/Hawthorne Street Renewal (Watford Street to Hartley Avenue section) project to proceed to detailed design, tender and construction.

Committee Recommendation:

- (a) That this matter be deferred until additional consultation with residents is carried out regarding the following options:

- (iv) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at a point 35 metres south of its intersection with Holmwood Road and extending in a southerly direction for 10 metres.
- (v) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at a point 57 metres south of its intersection with Holmwood Road and extending in a southerly direction for 6 metres.
- (vi) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at a point 71 metres south of its intersection with Holmwood Road and extending in a southerly direction for 21 metres.
- (vii) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at a point 118 metres south of its intersection with Holmwood Road and extending in a southerly direction for 9 metres.
- (viii) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at a point 138 metres south of its intersection with Holmwood Road and extending in a southerly direction for 36 metres.

- (ix) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at its intersection with Rhodes Street and extending in a northerly direction for 10 metres.
- (x) That the stopping of vehicles be prohibited at any time on the east side of Helmores Lane commencing at its intersection with Rhodes Street and extending in a southerly direction for 40 metres.

- (i) That the stopping of vehicles currently prohibited (at any time) on the north side of Rhodes Street commencing at its intersection with Rossall Street and extending in an easterly direction for a distance of 22 metres, be revoked.
- (ii) That the stopping of vehicles be prohibited (at any time) on the north side of Rhodes Street commencing at its intersection with Rossall Street and extending in an easterly direction for a distance of 29 metres.

- (iii) That the stopping of vehicles currently prohibited (at any time) on the north side of Rhodes Street commencing at a point 238 metres from its intersection with Rossall Street and extending in an easterly direction for 37 metres, be revoked (around the cul-de-sac turning circle).
- (iv) That the stopping of vehicles be prohibited (at any time) on the north side of Rhodes Street commencing at a point 238 metres from its intersection with Rossall Street and extending in an easterly direction for a distance of 50 metres (around the cul-de-sac turning circle).

New No Stopping - Rhodes Street (Helmores Lane to Rossall Street)

- (i) That the stopping of vehicles be prohibited at any time on the north side of Rhodes Street commencing at its intersection with Helmores Lane and extending in an easterly direction for 14 metres.
- (ii) That the stopping of vehicles be prohibited at any time on the south side of Rhodes Street commencing at its intersection with Helmores Lane and extending in an easterly direction for 16 metres.
- (iii) That the stopping of vehicles be prohibited at any time on the north side of Rhodes Street commencing at its intersection with Rossall Street and extending in a westerly direction for 17 metres.
- (iv) That the stopping of vehicles be prohibited at any time on the south side of Rhodes Street commencing at its intersection with Helmores Lane and extending in a westerly direction for 17 metres.

Rhodes Street (Rossall Street to cul-de-sac)

- (i) That the stopping of vehicles be prohibited at any time on the north side of Rhodes Street commencing at its intersection with Rossall Street and extending in an easterly direction for 29 metres.
- (ii) That the stopping of vehicles be prohibited at any time on the north side of Rhodes Street commencing at a point 82 metres east of its intersection with Rossall Street and extending in an easterly direction 11 metres.
- (iii) That the stopping of vehicles be prohibited at any time on the east side of Rhodes Street commencing at a point 107 metres east of its intersection with Rossall Street and extending in a southerly direction for 6 metres.
- (iv) That the stopping of vehicles be prohibited at any time on the south side of Rhodes Street commencing at a point 74 metres east of its intersection with Rossall Street and extending in an easterly direction for 43 metres.

14. DESMOND STREET - STREET RENEWAL IN THE FENDALTON SOUTH CLUSTER

The Committee's recommendation was sought for the Desmond Street Renewal project to proceed to detailed design, tender and construction.

Committee Recommendation:

That the Board:

- (a) Approve the Desmond Street plan, TP 310301, as attached to the Committee agenda, for final design, tender and construction.
- (b) Approve the following parking restrictions to take effect following completion of construction.

New No Stopping

- (i) That the stopping of vehicles be prohibited at any time on the north side of Desmond Street commencing at its intersection with Helmores Lane and extending in a westerly direction for 18 metres.
- (ii) That the stopping of vehicles be prohibited at any time on the south side of Desmond Street commencing at its intersection with Helmores Lane and extending in a westerly direction for 16 metres.
- (iii) That the stopping of vehicles be prohibited at any time on the south side of Desmond Street commencing at a point 115 metres west of its intersection with Helmores Lane and extending in a westerly direction for 24 metres.
- (c) That staff investigate, and consult Desmond Street residents, regarding the suitability of replacing the Japanese Maples with Liquidambars as the street trees in the proposed plan and to report this to the Board for a decision at the 19 May 2009 Board meeting.

The meeting concluded at 9.45am.

WATFORD CLUSTER – HARTLEY AVENUE: WORKS, TRAFFIC AND ENVIRONMENT COMMITTEE RECOMMENDATION

Staff have noted that the Fendalton/Waimairi Works, Traffic and Environment Committee made the following recommendation in relation to the Hartley Avenue/Hawthorne Street Renewal Project at its meeting on Monday 27 April 2009:

- (a) That this matter be deferred until additional consultation with residents is carried out regarding the following options:
 - (i) That the number of platforms and narrowings proposed in the plan for Hartley Avenue be reduced, in particular the removal of the two closest to the Normans Road intersection.
 - (ii) That the Hartley Avenue entrance/exit at Normans Road be widened to allow simultaneous left and right turning into Normans Road.
- (b) That when the report comes back for consideration, staff be requested to confirm that the street trees being recommended are deciduous.

Having considered the Committee's response, the project team now wishes to present additional information to the Board supporting the proposed scheme to obviate the need for further consultation as recommended by the Committee.

1) Number of Platforms and Narrowing

A formal Initial Issues consultation exercise was undertaken in July 2008. A total of 101 responses were received for the entire cluster (Halton Street, Hartley Avenue, Hawthorne Street and Urunga Avenue) by 4 August 2008. Of these 27 responses were received from residents in Hartley Avenue.

On traffic speed the following responses were noted:

Accordingly, over 17 respondents (65%) consider traffic speed in Hartley Avenue to be a moderate or serious issue.

Notable comments from residents include:

- Road is used as a shortcut through from Papanui Road;
- Safe crossing points are needed for children going to Waimairi School, or travelling across Normans Road at the end of Hartley Avenue to Heaton Intermediate / St Andrews College;
- Suggested solutions for speed: Narrowed road, lower speed limit, calming devices, school or children's signs, landscaping options to make it family friendly;
- To reach overbridge children should be encouraged to cross at Halton Street.

ATTACHMENT TO CLAUSE 9.11

Recent traffic surveys also recorded the following data for Hartley Avenue:

Hartley (o/s 31) - 24/7/08 to 31/7/08:

- 85%ile= 51.5 km/h
- max = 98.1 km/h
- 7d avg = 814 vpd

Hartley (o/s 88) - 31/7/08 to 13/8/08:

- 85%ile = 42.5km/h
- max = 66.8 km/h.
- 7d avg = 578 vpd

It should be noted that outside No. 31 Hartley Avenue (between Halton Street and Normans Road) the maximum speed recorded was 98.1 kmh and the 85%ile speed recorded was 51.5 km/h.

Whilst the posted speed limit is 50 km/h, it is known that there are vulnerable road users in the locality, notably school children (travelling to Waimairi School, St Andrew College and Heaton Intermediate), as well as elderly residents.

Based on this data the project team, which includes two professional traffic engineers, considered that traffic calming devices are necessary in order to improve safety. They support the view that 80 - 120 metre spacing of these devices is optimal for effective traffic calming. Two platforms are therefore required between the Halton Street and Normans Road intersections to achieve this.

Representatives from the project team also conducted two workshop sessions with the Waimairi School Travel Committee to discuss, in particular, the proposed layout at the corner of the Hartley Avenue and Hawthorne Street. The project team understands that the Travel Committee supports the proposed design for this corner.

The design seeks to provide maximum visibility of children crossing the road and reduce traffic speed to 30 km/h, or below. The raised platforms at the Halton Street intersection (and also along Hawthorne Street at Lansbury Avenue and Walnut Avenue) also assist in slowing down motor vehicles approaching this corner, especially as this is a busy area for both motor vehicles and pedestrians at the beginning and end of the school day.

Twenty four Hartley Avenue residents commented on the Hartley Avenue consultation plan. Although six respondents considered the number of proposed speed humps between Normans Road and Hawthorne Street excessive and two criticised aspects of the traffic calming treatments, 17 respondents stated that they generally supported the proposed plan. After considering feedback the project team increased the width of the narrowings from 5 metres to 6 metres to improve access to properties.

The proposed design for Hartley Avenue is consistent with treatments approved in other streets in the Watford Cluster. If the narrowings are removed in Hartley Avenue it is highly likely that more drivers will opt to use this street to avoid traffic calming measures in the surrounding streets

The proposed scheme has also been reviewed by an independent safety auditor. He had no queries about the number of road narrowings nor the width of the intersection with Normans Road.

2) Narrowing at Hartley Avenue / Normans Road Intersection

Changes to the existing narrowing at this intersection is outside the scope of the Hartley Avenue Street Renewal Project. The intersection was constructed in the 1991/92 financial year as part of the Normans Road (Strowan Road to Hartley Avenue) street renewal project and the asset is considered to have another 62 years of life.

As requested, should the Board wish to fund these alterations, an approximate rough order of costs to undertake this work as a separate project are set out as follows:

Construction Costs: \$10,000
Scheming & Consultation: \$12,000
Design, Documents & Supervision: \$6,000

Total \$28,000 (Excl GST)

ATTACHMENT TO CLAUSE 9.11

Any proposed alterations would be subject to an independent safety audit and it should be noted that such a change would fundamentally reduce the level of safety for all road users as follows:

- Pedestrians and cyclists crossing the intersection will have further distance across traffic lanes as well as a second lane of traffic turning out. At peak periods right turning traffic (particularly larger 4WD and SUV vehicles) will likely obscure visibility from the right for left turning vehicles and collisions may occur.
- There are significant volumes of vulnerable road users, particularly children travelling to and from Waimairi School, St Andrews College and Heaton Intermediate.

As discussed with the Committee, the existing width is a standard treatment across the city for all residential streets at intersections with collector and arterial roads and is consistent with other streets in the are, notably Watford Street (under construction), College Avenue and Urunga Avenue (recommended for approval). Narrowing entry points into local roads is designed to reduce traffic volumes and also short cutting, which has been identified as a problem by some Hartley Avenue residents.

3) Street Trees

The Project Team confirms that the proposed species of trees (Magnolia Vulcan) is a deciduous variety.

Impact on Project

If the project team were to undertake further consultation as recommended by the Committee at its meeting on 27th April 2009 it is expected this would incur a delay of 3 to 4 months and additional consultation costs in the order of \$10,000 to \$12,000, excluding GST.

Furthermore, it should be noted that the detailed design for Hawthorne Street cannot proceed as it is included in the same Board Report.

Conclusions and Recommendations

The project team has received professional advice which consistently recommends that the proposed plans for Hartley Avenue should not be altered as the design addresses the speeding issues raised by residents during consultation, noting that there are also vulnerable user groups, particularly school children, present in this area.

The existing narrowing of Hartley Avenue at the intersection with Normans Road is an existing asset which is considered to be outside the scope of this project and, if widened, is considered to reduce the level of safety for all road users.

The project team has conducted two phases of formal consultation – an initial issues consultation phase in July 2008 and full consultation on the proposed scheme in December 2008. In addition to this workshops were held with the Waimairi School Travel Committee to develop the design of the Hartley Avenue / Hawthorne St Corner, which is understood to be supported by the school. Accordingly the project team considers it has conducted sufficient consultation to date and further consultation is not necessary, noting that this would delay the project by up to 4 months and incur additional costs of up to \$12,000.

Accordingly, staff respectfully request that:

- 1) The Board does not accept the Committee's recommendations set out above; and
- 2) The Board approves the Staff Recommendations and proposed scheme for Hartley Avenue and Hawthorne Street (Watford Street to Hartley Avenue) as set out in the original Committee Report.

Should the Board still consider that the existing two calming devices on Hartley Avenue between Halton Street and Normans Road be removed then it is requested that consideration be given to a single calming device outside No 31 Hartley Avenue without further formal consultation.
