# 8. AIDANFIELD STAGES 8 AND 9 AND NOBLE VILLAGE SUBDIVISIONS - PROPOSED ROAD NAMING

#### **PURPOSE OF REPORT**

1. The purpose of this report is to obtain the Board's approval to nine new road names within the Aidanfield Subdivision Stages 8 and 9 and the Noble Village subdivision.

#### **EXECUTIVE SUMMARY**

- 2. The approval of proposed new road names is delegated to Community Boards.
- 3. The Subdivision Officer has checked the proposed names against the Council's road name database to ensure it will not be confused with names currently in use.

#### Aidanfield Subdivision Stages 8 and 9 - Attachment 1

4. These two stages of the Aidanfield subdivision are located between Halswell Road, Templetons Road, Aidanfield Drive and the Heathcote River. One hundred and forty residential sections will be created in stage 8, and a further thirty-four sections in stage 9. An esplanade reserve, 20 metres wide, will be created as part of the subdivision, running along the southern boundary of the river. As with all the previous names submitted for approval for the Aidanfield subdivision, the names proposed are those of former Sisters of the Good Shepherd Order, and former residents of the Good Shepherd Sisters Home at Halswell. The names proposed are Euphrasie Drive, Josephine Crescent, Benedict Street, Phelan Place, Kieran Grove, Canice Mews, Malachy Grove, Fintan Mews and Dympna Place. Three other names are provided as substitute names, if the Board declines any of the above names. These names are Aloysius, Augustine and Monica.

## Noble Village/Yaldhurst Road - Attachment 2

This is the first stage of the Noble Village subdivision on the former Applefields land in Yaldhurst Road. The property has several historical connections with the breeding and racing of Standardbreds. Born in Victoria, Sir John McKenzie spent 52 years of his life in New Zealand. He swiftly became famous as a businessman, and it was in the early 1920's that he became actively interested in the breeding and racing of Standardbreds. In 1927 Sir John established his Roydon Lodge Stud at Yaldhurst - an area now occupied by Noble Village and Broomfield Common. The stud quickly became established as one of the most important in the country. The McKenzie Residential School is adjacent to Noble Village, and is also on land formerly owned by Sir John McKenzie. George Noble was the head trainer at Roydon Lodge Stud. Noble was one of New Zealand's most capable and respected trainers. During a career which commenced in New Zealand in 1941, the former Australian trained and drove some of New Zealand's greatest pacers and trotters. He was the leading trainer in New Zealand on two occasions. The applicants have proposed the following names in keeping with the history of the property; Sir John McKenzie Avenue, George Noble Road, Farrier Road, Founders Lane, Gallop Lane, Stirrup Lane, Stud Road and Apple Orchard Lane.

# FINANCIAL IMPLICATIONS

5. There is no financial cost to the Council. The administration fee for road naming is included as part of the subdivision consent application fee, and the cost of name plate manufacture is charged direct to the developer.

#### **PURPOSE OF REPORT**

1. The purpose of this report is for the Riccarton/Wigram Community Board to consider an application for funding from its 2011/12 Discretionary Response Fund from Oasis Baptist Community Church for \$11,160.

#### **EXECUTIVE SUMMARY**

- 2. In 2011/12, the total pool available for allocation for the Riccarton/Wigram Discretionary Response Fund is \$72,491. This includes funds carried forward from 2010/11. The Discretionary Response Fund opens each year on 1 July and closes on 30 June the following year, or when all funds are expended.
- 3. The purpose of the Fund is to assist community groups where the project and funding request falls outside other council funding criteria and/or closing dates. This fund is also for emergency funding for unforeseen situations.
- 4. At the Council meeting of 22 April 2010, Council resolved to change the criteria and delegations around the local Discretionary Response Fund.
- 5. The change in criteria limited the items that the local Discretionary Response Fund does not cover to only:
  - (a) Legal challenges or Environment Court challenges against the Council, Council Controlled Organisations or Community Boards decisions;
  - (b) Projects or initiatives that change the scope of a Council project; and
  - (c) Projects or initiatives that will lead to ongoing operational costs to the Council.

Council also made a note that: "Community Boards can recommend to the Council for consideration grants under (b) and (c)."

- 6. Based on this criteria, the application from Oasis Baptist Community Church for a Produce/Clothing Bin is eligible for funding.
- 7. Detailed information on the application and staff comments are included in the attached Decision Matrix (**Attached**).

#### FINANCIAL IMPLICATIONS

8. There is currently \$48,251 remaining in the Board's 2011/12 Discretionary Response Fund.
