1. CONFIRMATION CHAIRPERSON

It was decided that the Committee appoint Steve Lowndes as Chairperson for this meeting.

2. CONFIRMATION OF MINUTES - 19 OCTOBER 2011

It was decided that the minutes be approved as a true and accurate record of the meeting, subject to the following alterations:

Alteration to clause 15 (Appointment of Regional Representative), to read:

'The Committee discussed the request to replace Claudia Reid as the Committees Representative on the Regional Committee, who has been unable to attend these recent meetings due to a number of other commitments.'

Alteration to clause 16.1 (Next Meeting – Tuesday 15 November 2011) to read:

'The Committee were advised of the next meeting of the Committee to be held on Tuesday 15 November, at 3 4pm in Akaroa Sports Complex. Chairperson Donald Couch tendered his apologies for this meeting.'

Alteration to clause 16.3 (General Public Contributions) to read:

'Committee Members raised concerns received from the public regarding Algal Blooms around Banks Peninsula particularly from Little Akaroa Alymers Valley stream, and suggested that this be an area that the Committee should consider investigating.'

6. REGIONAL COMMITTEE UPDATES

The Committee were updated on the relevant work of the Regional Committee, including:

- Primary focus on water quality and developing regional parameters and methods, and include the surface water quality.
- Update on the Regional Implementation programme.
- Work undertaken by the Hurunui-Waiau Zone Committee on the Hurunui River, with scientific input from Environment Canterbury staff and other professionals and stakeholders.

7. UPDATE ON WORK PLAN

Shelley Washington, Zone Facilitator, updated the Committee on the work programme for the coming months. It was suggested that the Committee may wish to consider setting up working parties to look at specific areas in depth and report back to the Committee.

It was **requested** that a coastal perspective be included in a future session, including consideration of the fresh water barrier with the sea, and the importance of this for fish migration and supporting other marine life.

8. **PLANNING 101**

The Committee received a presentation from Peter Skelton in relation to relevant statutory framework including the relationship between the framework and Resource Management Act Planning, and the implications for both the Regional Committee and the local Zone Committees.

9. ENVIRONMENT CANTERBURY PLANS

The Committee received a presentation from Peter Constantine regarding how the Canterbury Water Management Strategy fits in with redeveloping the regional plan. The proposed Regional Planning framework is split into three key areas - Air, Land and Water, and Coast, to simplify planning for the region. The Committee discussed the need to define the Coastal environment and the landward boundary before the elections in 2013.

The Committee were advised of the following key issues being raised by submitters to the plans:

- Water allocation;
- Water quality and the need to manage the land;
- The need for the consenting process to be simplified;
- Concerns over the effect of larger irrigation schemes.

10. CLIMATE SMART STRATEGY

The Committee received a presentation from Tony Moore in relation to the Climate Smart Strategy, specifically in relation to the role of the strategy in preparing for climate change, coastal change and expected sea level rises.

11. ADJOURNMENT

The Committee adjourned from 6pm to 6.30pm.

12. BIODIVERSITY STRATEGY

Liz Garson briefed the Committee on the Biodiversity strategy, outlining the main areas of work:

- Biodiversity Partnerships;
- Funding for five Banks Peninsula groups, which means they will no longer need to apply for grants as part of the operational budgets;
- Operational Pest management programme;
- Ecological data Management Systems.

13. BIODIVERSITY

Robyn Russ, Biodiversity Officer, briefed the Committee on the Immediate Steps funding programme, which aims to protect and restore freshwater biodiversity and water use affected terrestrial biodiversity in Canterbury. The Committee noted the different options for allocating funds to projects, and **decided** to use option 1, fund year one projects straight away based on merit, and decide on priority areas for remaining funding at a later date.

14. OTHER MATTERS

14.1 PROPOSED ZONE COMMITTEE FIELD TRIP - SUNDAY 20 NOVEMBER 2011

The Committee confirmed the arrangements for the field trip to be held on Sunday 20 November 2011.

14.2 UPCOMING PUBLIC WORKSHOPS

The Committee were updated on the progress with the public workshops, and were advised that newsletters will be sent to letterboxes and that adverts have been circulated to the Akaroa Mail, Lyttelton Harbour News and that emails have been sent to all those that signed up to receive information. The format for the public workshops will be to begin with an overview of the role of the Committee and the Canterbury Water Management Strategy, and then break off into smaller groups to identifying key issues and possible solutions, which would be facilitated by staff and Committee Members. Iaean Cranwell, Councillor Claudia Reid and Yvette Couch-Lewis indicated that they were available to help facilitate.

14.3 NEXT MEETING

The next meeting of the Committee will be held at 4pm on Tuesday 20 December 2011, in the Lyttelton Recreation Centre.

Recommendations	That the Zone Committee: Note the ecological and cultural scores for each proposed Immediate Steps Biodiversity project and then identify which projects they wish to allocate funds to.

PURPOSE

To report to the Zone Committee the ecological and cultural scores associated with each of the proposed Immediate Steps Year One projects. Further details including maps, pictures, values and threats at each project site will be provided at the meeting. The table provided below gives the Zone Committee members a chance to get a feel for the ecological and cultural values for each project before attending the meeting on the 20th of December. The paper also gives each Zone Committee member some time to think about any questions, expressions of support/concern for each project and bring them along to the meeting.

It is hoped that the Zone Committee will have received enough information and feel confident by the conclusion of the meeting to decide which projects they wish to allocate Immediate Steps Funding to for Year One.

RECOMMENDATION

That the Zone Committee allocates Year One Immediate Steps funding to those projects that they feel have the highest ecological and cultural values and which help them to achieve the targets and goals of the Canterbury Water Management Strategy.
