PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Riccarton/Wigram 2010/11 Youth Development Scheme.

EXECUTIVE SUMMARY

2. The applicant, Abigail Susan Warrington, is a 15 year old Halswell resident and is seeking Community Board support to travel to Dublin to compete in the World Irish Dancing Championships. This trip will take place from 11 April – 2 May 2011.
3. Abigail has been participating in the sport of Irish dancing since the age of five and currently attends lessons twice weekly at the Kay-Hallissey Dance School. Abigail has competed at both Regional and National level as well travelling to Australia to experience international competition. Abigail has been placed in the top three at New Zealand Championships since the age of five as well as achieving top five placings in international competition.
4. Through her dedication to her sport, Abigail has become a worthy ambassador for New Zealand and her achievements have gained her selection to compete on the world stage. It has been Abigail's goal to dance on a world stage and she feels competing at these championships will help her gain confidence to grow as a dancer and aspire to much greater achievements.
5. Abigail has raised \$2,200 to date through busking and will continue to fundraise until she goes away. Abigail would appreciate any assistance from the community board.
