# MINUTES OF A MEETING OF THE METROPOLITAN FUNDING COMMITTEE

#### **METROPOLITAN STRENGTHENING COMMUNITIES FUND 2011/12**

Michael Aitken (General Manager, Community Services) and Carolyn Gallagher (Unit Manager, Community Support) spoke to the report prepared by Duncan Innes (Community Grants Funding Team Leader). Staff addressed the following with the Committee:

- Strengthening Communities Strategy's Outcomes and Priorities.
- Update on funding events since the earthquake of 22 February 2011.
- Lincoln Papali'i (Strategic Initiatives Manager) updated the Committee that two applications were miscoded and needed to be added to the funding matrix.
- Staff indicated and clarified that there is an error in one KLP balance.
- MOA Kids Redcliffs Early Learning Centre has approached the Council for \$32,000 for rent. There is no formal application for this.
- Staff advised that the report did not cover the options for the future funding of environmentally-based projects, including whether these projects could be considered as line items, which had been requested at the 5 July 2010 Metropolitan Funding Committee workshop. A further report on this issue would be presented to the Council, later in the year.
- Staff tabled a memorandum on the status of the top ten major organisations as at July 2011. This included \$240,000 for the Christchurch Cathedral.

#### SUSPENSION OF STANDING ORDERS
