PURPOSE OF REPORT

- 1. The purpose of this report is for the Spreydon/Heathcote Community Board to consider two applications for funding from its 2011/12 Discretionary Response Fund from:
 - a) Adventure Specialties Trust for \$1,600 towards the Family Camp.
 - b) Addington Action for \$1,850 towards the Earthquake Recovery project costs.

EXECUTIVE SUMMARY

- 2. In 2011/12, the total pool available for allocation for the Spreydon/Heathcote Discretionary Response Fund is \$51,197. The Discretionary Response Fund opens each year on 1 July and closes on 30 June the following year, or when all funds are expended.
- 3. The purpose of the Fund is to assist community groups where the project and funding request falls outside other council funding criteria and/or closing dates. This fund is also for emergency funding for unforeseen situations.
- 4. At the Council meeting of 22 April 2010, Council resolved to change the criteria and delegations around the local Discretionary Response Fund.
- 5. The change in criteria limited the items that the local Discretionary Response Fund does not cover to only:
 - (a) Legal challenges or Environment Court challenges against the Council, Council Controlled Organisations or Community Boards decisions;
 - (b) Projects or initiatives that change the scope of a Council project; and
 - (c) Projects or initiatives that will lead to ongoing operational costs to the Council.

Council also made a note that: "Community Boards can recommend to the Council for consideration grants under (b) and (c)."

- 6. Based on these criteria, the applications from Adventure Specialties Trust for \$1,600 towards the Family Camp and Addington Action for \$1,850 towards the Earthquake Recovery project costs are eligible for funding.
- 7. Detailed information on the application and staff comments are included in the attached Decision Matrix. (Attachments 1 and 2).

FINANCIAL IMPLICATIONS

8. There is currently \$51,197 remaining in the Board's 2011/12 Discretionary Response Fund.
