# 8. APPLICATION TO THE RICCARTON WIGRAM 2010/11 YOUTH DEVELOPMENT SCHEME – KEZIAH ANNE OLIVER

#### **PURPOSE OF REPORT**

1. The purpose of this report is to seek approval for an application for funding from the Community Board's 2010/11 Youth Development Scheme.

#### **EXECUTIVE SUMMARY**

- 2. The applicant, Keziah Oliver is an 18 year old Riccarton resident, who is seeking Community Board support to travel to Malaysia to compete in the Malaysian Intercity Championships in Rhythmic Gymnastics and to also gain selection for the World University Games in August. This trip will take place 2 3 April 2011.
- 3. Keziah is currently studying at the University of Canterbury and moved to the Riccarton area this year. Prior to this Keziah resided in Halswell for 12 months. Keziah's parents currently reside in Brisbane and she moved here to pursue her goal of National representation and is a NZ citizen. Keziah presently is the highest ranking rhythmic gymnast in New Zealand and is currently training towards another demanding international season. In 2010 Keziah was part of the team that placed fourth at the Commonwealth Games and preceding this competed in several other domestic and international competitions.
- 4. Keziah is currently training up to 35 hours a week under her Russian coach, Galina Safronova and Kathryn Holdsworth at Olympia Gymnastic Sports, and they believe that with increased international exposure, Keziah has a real chance of making an impact internationally. In order to gain selection to compete at the World University Games in China in August, Keziah must compete and perform highly in Malaysia.
- 5. Keziah's has currently raised \$1,300 towards her trip expenses through sausage sizzles, coaching at Olympia Gymnastic Sports and selling leotards. Keziah has also applied to various other funding agencies and her applications are currently pending.

#### FINANCIAL IMPLICATIONS
