1. MINUTES OF PREVIOUS MEETINGS: 29 APRIL 2011 AND 24 JUNE 2011 (SPECIAL MEETING)

It was **resolved** on the motion of Councillor Lindsay Philps, seconded by Councillor Dick Davison, that the minutes of the Canterbury Regional Landfill Joint Committee held on 29 April 2011 and of the Special Meeting held on 24 June 2011, as circulated, be confirmed as a true and correct record of the meeting.

2. CORRESPONDENCE

Councillor Sally Buck advised that correspondence had been received from Councillor Dick Davison raising matters that would have been dealt with in the Workshop to follow this meeting. She had subsequently sent a memo advising that the Workshop had been postponed due to Christchurch City Council staff commitments. An additional item had been placed on the Agenda to deal with these matters in the interim.

3. APPOINTMENT OF A DIRECTOR REPRESENTING HURUNUI, WAIMAKARIRI, SELWYN AND ASHBURTON DISTRICT COUNCILS

Nominations had been received from Councillor Robbie Brine and Councillor Dick Davison.

It was resolved on the motion of Councillor Lindsay Philps, seconded by Councillor Sally Buck, that:

- Councillor Glenn Livingstone and Councillor Lindsay Philps be appointed to a subcommittee responsible for obtaining proposals for carrying out the selection process from a number of HR Consultants and bringing back a recommendation to this Committee.
- 2. That Councillor Robbie Brine be re-appointed as the Councillor Director to represent the rural councils on the Board of Transwaste Canterbury until a new appointment is made.

3. That the costs of contracting a HR Consultant be apportioned between all five member councils, based on the population figures in Clause 27 of the Constituting Agreement.

4. APPOINTMENT OF A DIRECTOR REPRESENTING CHRISTCHURCH CITY COUNCIL

It was **resolved** on the motion of Councillor Glenn Livingstone, seconded by Councillor Robbie Brine that Councillor Sally Buck be appointed as the Councillor Director to represent Christchurch City Council on the Board of Transwaste Canterbury until 28 February 2014.

5. APPOINTMENT OF A REPRESENTATIVE TO ATTEND THE TRANSWASTE CANTERBURY LTD ANNUAL GENERAL MEETING

It was **resolved** on the motion of Councillor Sally Buck, seconded by Councillor Dick Davison that this Committee appoint Councillor Glenn Livingstone to attend and vote at the Transwaste Canterbury Ltd Annual General Meeting in November 2011 and that Councillor Lindsay Philps be appointed as alternate.
