CREATIVE COMMUNITIES SCHEME - REPORT TO COMMITTEE

Round 2, 2011/12 closed 24 February 2012

This round has generated 94 applications which is more than double the number received in the last round in August. This number reflects the resurgence of arts groups and individuals in the city and their flexibility and creativity with venues and spaces. Recommendations are for 88 applications to be funded with six application being withdrawn as they did not meet the criteria or were unsuitable for this fund. Each of these six applicants have been contacted and given explanations for the withdrawals. They are able to apply in the next round.

The total available for this round is \$183,872 made up of Creative NZ allocation plus an extra \$21,000 for this round. There has also been an increase in the per capita amount from 60 cents to 67 cents which has resulted in the increased amount. \$166,119 has been recommended for distribution. This leave a balance of \$17,753 which is available to the Committee for some increases in the recommended allocations. Any remaining funds will not be carried forward into the next financial year.

The Creative Communities Funding Scheme (CCS) continues to support arts projects in the community, giving emerging artists and organisations the opportunity to focus on their art for the benefit of the Christchurch community. Creative New Zealand spends \$2.7 million each year supporting around 2,500 projects through CCS. The scheme is a key platform in Creative New Zealand's partnership with local councils in developing the arts.

CCS three funding criteria:

- <u>1.</u> <u>Broad community involvement</u> project will create opportunities for local communities to engage with and participate in arts activities.
- <u>2.</u> <u>Diversity</u> project will support the diverse arts and cultural traditions of local communities, enriching and promoting their uniqueness and cultural diversity.
- 2. Young people project will enable and encourage young people (under 18 years) to engage with and actively participate in the arts.
