PURPOSE OF REPORT

1. The purpose of this report is for the Hagley/Ferrymead Community Board to consider one application for funding from its 2012/13 Discretionary Response Fund from The Friends of Linwood Cemetery Charitable Trust who seek \$4,000.

EXECUTIVE SUMMARY

- 2. In 2012/13, the total pool available for allocation for the Hagley/Ferrymead Discretionary Response Fund is \$51,197. The Discretionary Response Fund opens each year on 1 July and closes on 30 June the following year, or when all funds are expended.
- 3. The purpose of the Fund is to assist community groups where the project and funding request falls outside other council funding criteria and/or closing dates. This fund is also for emergency funding for unforeseen situations.
- 4. At the Council meeting of 22 April 2010, Council resolved to change the criteria and delegations around the local Discretionary Response Fund.
- 5. The change in criteria limited the items that the local Discretionary Response Fund does not cover to only:
 - (a) Legal challenges or Environment Court challenges against the Council, Council Controlled Organisations or Community Boards decisions
 - (b) Projects or initiatives that change the scope of a Council project and
 - (c) Projects or initiatives that will lead to ongoing operational costs to the Council.

Council also made a note that: "Community Boards can recommend to the Council for consideration grants under (b) and (c)."

- 6. Based on these criteria, the application from The Friends of Linwood Cemetery Charitable Trust for Oral Histories and Heritage Information Associated to 45 People Buried in Linwood is eligible for funding.
- 7. Detailed information on the application and staff comments are included in the Decision Matrix (refer **Attachment 1**).

FINANCIAL IMPLICATIONS

8. At the time this report was prepared there is currently \$37,697 remaining in the Board's 2012/13 Discretionary Response Fund.

PURPOSE OF REPORT

1. The purpose of this report is to seek approval for an application for funding from the Hagley/Ferrymead Community Board 2012/13 Youth Development Scheme from Leon Jarden.

EXECUTIVE SUMMARY

- 2. Funding is being sought by Leon Harry Jarden, a 14 year old of Bromley to represent New Zealand in the U15 Mixed Touch Team in Australia from 7 to 14 October 2012. The application was received in May 2012, however, due to the cost of the trip, the application has been on hold pending the results of other fundraising efforts.
- 3. Leon is one of 16 players selected to participate in the U15 Mixed Touch Team development tour to Sydney. The tour takes place during the school holidays and the players will be participating in an organised tournament and night games against local teams. Leon was selected from players across New Zealand, in February to join the team. He is considered a gifted young athlete with a very promising future to achieve at the highest level in the sport. New Zealand and Australia are the top two countries in the world for Touch and this programme is an important talent development pathway opportunity. Following on from the development tour Leon will take part in the annual national tournament in 2013 and if selected he will be eligible to play in the Super Trans Tasman tournament.
- 4. A dedicated athlete, Leon plays touch for New Brighton touch team Carvers every Monday, trains everyday for league and plays on Saturdays for Celebration and plays rugby for Shirley Boys High, if it does not clash with league games. He has represented Canterbury Touch and League every year, since 2007. In the future, Leon's goal is to play National Rugby League and to play for the Kiwis one day. Leon also enjoys boxing and going to the gym.
- 5. In terms of fundraising, all players are expected to raise the funds themselves because they come from across New Zealand and Touch New Zealand does not have any funding. This has been particularly challenging for Leon and his family due to financial circumstances and individual fundraising efforts required. However, through sheer determination Leon will go on the trip due to family commitment, fundraising raffles, sausage sizzles and support from Shirley Boys High and Ngai Tahu.

FINANCIAL IMPLICATIONS

6. The total expenditure for the Touch New Zealand trip consisting of two mixed teams (U15 and U17 of 16 players each), a tour manager, an elite player manager, a coaching mentor and a physiotherapist is \$108,914.50. Each player must contribute \$3,500 towards the overall cost of the trip. The following table outlines the overall costs for the trip.
