- 4. Courtney is aiming to qualify for selection in the NZ team to compete at the 2012 Pacific Rim Championships and her results in the upcoming training camp in Utah will provide the platform for this selection. If not selected the remaining athletes will compete in a local competition in Seattle.
- 5. Courtney's sporting expenses are predominantly covered by her family and she is hoping to raise funds through upcoming fundraising opportunities such as sausage sizzles and event marshalling work. She would appreciate any financial assistance from the Board.
