CONSULTATION ANALYSIS

Summary for Hearings Panel

Strategy & Planning Group Christchurch City Council

June 2012

1. SUMMARY

On 4 May 2012 the Christchurch City Council publicly notified the Alcohol Restrictions in Public Places Amendment Bylaw 2012 (the amendment bylaw). The amendment bylaw proposes to create permanent alcohol bans, on Wednesday, Thursday, Friday and Saturday nights from 6pm to 6am for areas of Merivale and Papanui.

38 people made submissions with 37 of the 38 submissions in favour of the proposal for permanent alcohol bans. One submitter (submission 3) opposed the permanent alcohol bans because he considers that the permanent bans are unnecessary and an infringement on personal liberty.

In addition to the formal submissions, Kennedy Graham, MP sent an e-mail in support of permanent bans and the Fendalton/ Waimairi and Shirley/ Papanui Community Boards provided informal positive feedback and comment on the proposals. Shirley/ Papanui Community Board also asked for the Papanui ban area to be extended north along North Road to the intersection with Cranford Street.

2. ANALYSIS OF SUBMISSIONS

Appendix 1 to this report provides a summary of the 38 submissions. With respect to the 37 submissions supporting the proposed bylaw amendment, 12 submissions are in support of the proposed permanent Merivale alcohol ban area, nine relate to the Papanui ban area and 16 submissions either express support for both Merivale and Papanui alcohol bans or express approval for permanent alcohol bans without direct reference to the specific areas.

Most (32 of 38) submissions are from residents or owners of properties within or adjoining the proposed Papanui and Merivale alcohol ban areas, five are from people living outside the area(s) and one submission (Submission 35) is from an organisation- the Sigjaws Trust, an advocacy group working with people with disabilities.

Some of the submissions are brief and simply support the proposed alcohol ban(s) but most submitters provide reasons for their positions on the bylaw. Submissions include comment on a range of matters including the need for better enforcement of bans, problems associated with licensed premises and support for a law change to make "being drunk in a public place' an offence. Eight people in their submissions ask for the proposed bans to be amended –either to extend the hours/days on which the bans apply or to extend the ban area. The requested amendments are outlined below.

Submissions in support of the proposed amendment bylaw

37 of the 38 submitters support the proposed Amendment Bylaw 2012. The following is a summary of the most frequently given reasons for supporting the permanent bans:

- Incidences of street disturbances, littering and/or vandalism due to alcohol are a significant concern.
- Migration of the central city bar district to the suburbs has exacerbated the alcohol related problems for the area(s).
- The temporary alcohol ban(s) improved the situation with less litter and vandalism and fewer disturbances.

Eight submitters seek amendments to the proposed bylaw:

- Papanui ban to apply seven days a week. (Submissions 7,16,19)
- Merivale ban to apply seven days a week. (Submission 8,19)
- Papanui ban to apply at all times (24/7). (Submission 14)
- Extend Papanui ban area north along North Road to the intersection with Cranford Street (Submission 25)
- Extend Merivale ban area to include Elmwood Park. (Submission 28)
- Extend Merivale ban area south to the intersection with Bealey Avenue. (Submission 17)

Submission opposing the proposed amendment bylaw

One submitter (Submission 3) opposes the bylaw amendment to create permanent bans because:

- The pressure on bars in the area will continue to ease and permanent bans are therefore unnecessary.
- The bylaw will unnecessarily restrict people's freedom and criminalise otherwise law abiding citizens.
- The bylaw is a heavy handed approach when a small minority create the problems.
- Any problems should be addressed by police enforcement of other laws. The offence of being drunk in a public place should be re-introduced.
- It is not the role of Council to get involved in addressing societal behavioural problems as this role is a function of the State.

3. COMMENTS AND CONCLUSIONS

Eight submitters and the Shirley/Papanui Community Board have sought changes to the notified proposals for alcohol bans. Staff consider that any decisions on the requests for additions and alterations should be made when the alcohol bans are reviewed rather than during the current approval process. The proposed changes are not minor technical amendments and the Council would need to consult with potentially interested and affected parties to gain their views and preferences about such changes. In addition the Council would need to have better information as to the costs and benefits of the proposed changes.

Overall the analysis of the submissions (Section 2 above) aligns with the results of an informal consultation carried out in January and February 2012 which identified widespread community support for permanent alcohol bans in Merivale and Papanui. While one submission opposes the proposed amendment bylaw as unnecessarily restricting the freedom of otherwise law-abiding people, there are 37 supporting submissions for permanent alcohol bans for Merivale and Papanui.

	In general principle I am against blanket bans to solve societal problems caused by a minority grouping within the community. More and more, Government (both local and national) are eroding individual freedom and rights as an easy solution to problems which require resources and effort to solve. While the temporary ban may have given extra tools to enforcement agencies under unusual circumstances, the pressure on bars and restaurants in this area must have eased and as more entertainment facilities re-open in other areas , will continue to do so. I am therefore against the proposal to introduce a permanent ban.	
	I am 66 years of age, so have accumulated a certain amount of wisdom in observing the human psyche. There are many laws on the statute book which can deal with the antisocial aspects of alcohol consumption in public places, but require the Police to follow proper procedures when taking action. The proposed bylaw allow them to take steps which are not accountable and opens the door to abuse of power from the State. There used to be a law on the statute books making it an offence to be drunk in a public place. Why this was removed is quite beyond me and a re-introduction of it would make sense. I suspect the Police would not be happy, because it then requires resources and paper work. Laws made, which impact on many, to solve societal problems caused by a few to make policing easy, are not good laws.	
	Whilst the purpose of extending the by-law (one may presume that eventually in time it will cover most of the City) may have an intended focus on a troublesome target group, it turns innocent law abiding citizens into criminals and gives the State excuses to exercise powers of stop and search on the slightest pretext. If we choose not to drink the whole bottle of a special wine at a BYO restaurant or a private dinner party, we should be free to return home with it to consume at our leisure without fear of interference and retribution from the State. Whilst the argument will be that such a situation is unlikely, once passed into law the potential remains.	
	In summing up, my view of the City Council role, is for it to provide services to it's citizenry. Roads, rubbish, water, public parks and facilities and provide bylaws to facilitate the smooth running of those services. Societal behavioral problems are the function of State agencies to grapple with and solve and I object to the intrusion in my life by local council representatives and officials into matters which I think should not be of their concern. Blanket bans are not the answer.

	I am in favour of the permanent alcohol ban for Merivale and Papanui but I would like it to be 7 days a week and for Council to not approve any more licenses (e.g. Club 22) in these areas and explain to residents how these will be policed as we have had several alcohol fuelled incidents which have left our extended family afraid in the evening.
	 I would make the following points however: Why would council approve more pubs/nightclubs in these areas if they want a permanent alcohol ban e.g. club 22 is applying for a licence. They are applying for a 7 day a week licence so if it goes ahead this will only increase the number of drunken people in the neighbourhood and the number of youth drinking in side streets prior to going to the bars (and nightclubs). We have had drunk intruders on our property and last Saturday night my wifes mother had a beer bottle thrown at her back windscreen (shattering it) at 10pm while she was driving the car by 10-15 drunken youths outside the Papanui railway station – the police were too busy to turn up! There have ben numerous other incidents that residents in St James and Matsons Aves could recount. How is the liquor ban policed – there are not enough police around (example above). I understand there are 3 police in the evening in Chch – is this correct? I am unsure of the evidence behind the comment in the public consultation flyer saying 'the temporary bans appear to have been effective" We certainly do not feel safe in our neighbourhood anymore. Our youngest child is quite scared when she regularly sees police lights outside our property and our older children now are not allowed to walk to or from the youth centre (400 m away) at night. 	I am emailing this as there is no link to it on your Have A Say page.
	I am writing in full support of the proposal to extend the ban from temporary to permanent. Regardless of whether the CBD eventually is able to provide revellers with alternative venues there are a number of bars in the Merivale area that will continue to receive strong patronage in the future. While the bars around here tend to attract an older and slightly better behaved crowd than the student venues in Riccarton there is significant and growing public push-back on public drunkeness and a desire to see our heavy drinking culture curbed. Even with the ban in place we still get drinking related rubbish, vandalism and late night yahoos. With a late-night MacDonalds just across from the bars hungry patrons tend to go there in the early hours and happily drop their litter (and sometimes a good deal of the food) as they wander home through the nearby streets. The worst issue is broken glass that is dangerous to kids and pets and hard to clean up effectively. It simply should not have to be a Saturday and Sunday morning hazard. Some of the vandalism is mild (road cones thrown into gardens) but with so much road works these days damage can be done to parked cars, fences and other property and as this is city property the damage to the road work gear is a financial loss to the rate payers. They often pull out corner safety signage as well and this has to be repaired or replaced. I would also like the proposal extended to all nights. Regardless of how busy the bars are on the slower nights all it takes is a small number of people to do the damage. There is no need for drinking to occur in the streets at any time. Also the bans mean the Police can focus on more important work and not have their time wasted dealing with drunk people or the mess they make.
	All of this makes me sound like a big "downer". I am not anti-drinking or anti-fun. I enjoy drinking alcohol both at home and out with friends. Christchurch's citizens need to be able to have a drink or two to relax and de-stress but should be able to do so in safe and fun environments free of drunken idiots. Our streets and our lives have already been dramatically affected by the earthquakes so our tolerance for selfish idiots is much lower now I think.

	Keeping this alcohol ban in place is only any use to us if the ban is controlled and patrolled. Recently we called the Police around 2am as a group of about 10 people decided to have a party directly in front of our home. There were people drinking directly from spirits bottles and fighting. Following our call to the Police, we were pleased and comforted by their arrival But when the "lead" policeman said to the people "just keep your noise down and don't be too much longer" we knew that we had a continuing issue with the alcohol ban.
	We have a single tenant in an apartment next door to our address who still puts up with people walking in her garden, past her bedroom and living room, to urinate in her garden. She lives with her curtains fully pulled closed now, so worried is she now. A law is fine, but it means nothing if it is not enforced - we believe that these people are just returning from nearby bars and not actually carrying alcohol publicly. - People now rarely hang around the public toilets at night causing a public nuisance and damage.
- We are no longer subjected to intoxicated youths in loud cars speeding down the avenue.
