PURPOSE OF REPORT

1. The purpose of this report is to seek the Board's approval to install a Loading Zone on the north side of Burke Street.

EXECUTIVE SUMMARY

- 2. Council staff have received correspondence from Cranfield Glass Limited that due to the high parking demand in Burke Street, there is no loading area for trucks to load/unload. This results in the vehicles being parked in the middle of the street while unloading, which causes safety issues. The customer has requested that the Council install a P5 Goods Vehicles Only Loading Zone Parking Restriction in this area. (Attachment 1).
- 3. This area is zoned as Business 3 (Inner City Industrial). A site parking survey and site visits found that the parking demand is very high and there are always trucks loading/unloading goods in the traffic lanes. A loading zone will ensure that there is a safe location for goods to be loaded unloaded.

FINANCIAL IMPLICATIONS

4. The estimated cost of this proposal is approximately \$300.

The installation of signs and road markings are covered by Transport and Greenspace Operational budgets.

CHAIRPERSONS RECOMMENDATION

BACKGROUND

Jo Murgatroyd

- 14. Jo attends Christchurch Polytechnic Institute of Technology (CPIT) Jazz School with about 50 other students. Prospective students have to apply to attend the Jazz school by submitting an application, curriculum vitae and taking a theory test and a practical audition. Jo won a Music Scholarship from Westonian Society to assist with her studies. She came top in her class for the last two years in high school Music and also passed Level four Jazz Improvisation Certificate in her last year at school. (The last year at school is typically Level three).
- 15. Jo and some of her Jazz School classmates have elected to go on the trip to experience expert tuition and immerse themselves in the famous New York jazz scene. Although this is an elective trip, Jo has proven that she is dedicated to her art and she can achieve at a high level. She aims to use this trip to apply what she has learnt at Jazz School and to receive tuition with some of the top jazz musicians in New York. The group also plan to visit iconic and historical jazz places such as 'Tin Pan Alley' and go to live performances.
- 16. Jo has been involved in music since she was 12 years old and has been participating regularly in musicals and singing showcases. Jo took singing classes twice per week and dance/drama class once per week for nearly five years before switching to private vocal tuition. Her performance highlights over the last three years are many and varied. She has performed solo (vocal and piano), in concerts and in chorus for productions.
- 17. Jo is fundraising by writing songs for donations, busking and working weekends. She has also applied to the Freeman X Foundation for funding assistance.

Samuel Thomas

- 18. Samuel attends Christ's College and has been sailing for about 10 years. Three years ago he was selected for the Canterbury Yachting Association 420 Youth Development programme. The programme includes an average of 12 hours training per week during the sailing season and competing at major national regattas. He also belongs to the Huxter Mountain Bike club where he has been involved in track building.
- 19. Samuel is head of the Sailing Club at Christ's College and has volunteered as a coach for Learn to Sail groups. His sailing crew came second in the 420 Nationals earlier this year and as a result they qualified for the 420 Open World Championships. The 420 is a two person dinghy sail boat which is the youth version of the 470, an Olympic class boat. Because Samuel's crew qualified second in New Zealand they will not receive funding from Yachting New Zealand to participate in the Worlds.
- 20. Samuel is fundraising by being involved in a Quiz night, Auction dinner and working part-time in a labouring job.

Zabihullah Lali

- 21. Zabihullah attends Cashmere High School and plays for the school Futsal team that recently won the New Zealand Secondary Schools Futsal Championship. He also plays football for the school's First XI and in the men's team for the Ferrymead Bays (Premier Development League) team. He has been playing football since he was a child living in Afghanistan.
- 22. Zabihullah has just been selected for the Canterbury U19 Futsal team to compete in the National Futsal Championship in Wellington. The team is coordinated by Mainland Futsal who have put together an itinerary for the competition for one fee that covers all costs. Futsal is played on a smaller pitch, often indoors and is the official Fédération Internationale de Football Association (FIFA) version of indoor 5-a-side soccer. It is a fast and creative game that requires good ball skills and is often used to improve a football players 11-a-side game.
- 22. Zabihullah has been working part-time to pay for his school fees and help with other family expenses. He does not have other funding to put towards this trip. He would like to attend this trip to help improve his game at top level futsal and show his ability to selectors.

Secondary School Kapa Haka in Christchurch

The opportunity was made available for these students to join in 'Nga Toka Hapai' which is a combined schools group made up of students from eight Christchurch schools. Students were selected after an audition process and the group will compete at the New Zealand Secondary School (NZSS) Kapa Haka competition.

Marley Wilcox-Nanai

15. Marley is passionate about music, he has loved singing from a young age and his favourite instrument is the guitar, which he teaches himself to play. Marley is currently in the care of his Nana and has recently faced various family and financial challenges. He shows good commitment to kapa haka by taking the bus from Hoon Hay to Papanui for every practice. The teacher leading 'Nga Toka Hapai' describes Marley as dedicated, enthusiastic and a great role model for the other students (in terms of his commitment). Marley takes part in all the fundraising activities which includes two Haangi's, sausage sizzles and raffle.

Poppy Peate-Garratt

16. Poppy is one of two Cashmere High School students selected for 'Nga toka hapai' to compete at the NZSS Kapa haka competition. She has been performing in kapa haka groups for the last five years and has been studying Te Reo for the last three years. Poppy trained for over 100 hours last year with the Te Haeata group for the Regional competition that was cancelled. She was also awarded a school Merit Award for Kapa Haka last year. Poppy has also been involved in fundraising activities with the group.
