PURPOSE OF REPORT

1. The purpose of this report is to present to the Board an application for funding assistance from the Spreydon/Heathcote 2011/12 Youth Achievement Scheme fund.

EXECUTIVE SUMMARY

- Funding is being sought by Rebecca Howie, 16 years old from Spreydon, to represent the New Zealand Secondary Students Choir (NZSSC) at the Ihlombe South African Choral Festival from 1–17 July 2012.

BACKGROUND

- 14. Rebecca attends Cashmere High school where she sings with the school choir and is studying Music at NCEA Level three. She has been singing in school choirs since primary school and in her last two years before starting high school she was selected as a member of the 'Special Choir' for the Christchurch Schools' Music Festival. Rebecca has performed solo in various choirs, concerts and also at the Big Sing regional schools competition. She has also sung solo at the ANZAC Day Service in Halswell for the last two years.
- 15. Rebecca auditioned for the New Zealand Secondary Students Choir in early 2011 along with 250 other students. Only 61 students were selected to sing with the choir for an 18 month contract. Every choir goes on an international tour in the last 6 months of the contract. This year the choir will tour South Africa to perform at a music festival with other national choirs. The tour includes Johannesburg, Capetown and Pretoria where the students will perform at concerts, attend workshops and learn about other cultures.
- 16. Rebecca has raised money from many sources to fund the trip including two part-time jobs, busking, and singing at community events. Rebecca plans to study classical singing and composition towards a Bachelor of Music at the New Zealand School of Music in Wellington.
