It was **resolved** on the motion of Mayor Coe, seconded by Councillor Lyall, that the apologies be accepted.

The meeting was adjourned at 11.05 AM, so that the business of the Canterbury Earthquake Recovery Authority (CERA) Advisory Committee could be completed.

The meeting of the Urban Development Strategy Implementation Committee (UDSIC) resumed at 12.20 PM.

#### 2. RESOLUTION TO EXCLUDE THE PUBLIC

On the motion of Councillor Gerard, seconded by Mayor Coe, the Committee **resolved** to exclude the public on the grounds of *Maintaining Legal Professional Privilege*, as set out on page 43 of the agenda for this meeting.

#### 7. GREATER CHRISTCHURCH TRANSPORT STATEMENT: UPDATE REPORT

The Committee acknowledged the hard work and commitment of staff who had pulled together information from a wide range of sources, so that an outline for the Greater Christchurch Transport Statement (GCTS) could drafted within the timeframe of one month.

The Committee noted that:

- the development of a GCTS is underway
- the GCTS will be developed through a partnership approach between Urban Development Strategy (UDS) partners\*, CERA, Lyttelton Port of Christchurch, Christchurch International Airport Limited, Kiwirail and the Ministry of Transport.

It was **agreed** on the motion of Commissioner Rex Williams, seconded by Commissioner Peter Skelton, that:

- a. although the Greater Christchurch Transport Statement would be a non-statutory document, a Memorandum of Understanding would be developed by Urban Development Strategy (UDS) partners<sup>\*</sup> and other key stakeholders to indicate their commitment to the statement
- b. a further report will be provided at the next Committee meeting on 10 August 2012, which will include a draft of the Greater Christchurch Transport Statement for comment
- c. following comment from this Committee, the Greater Christchurch Transport Statement will be presented for adoption by the Committee and referred to Urban Development Strategy partners and other key stakeholders for ratification.

#### 8. BI-MONTHLY IMPLEMENTATION REPORT

The Committee thanked staff for organising the bus tour (noted in the report) and indicated that it had been a valuable exercise both in terms of developing members' understanding of the issues, and as an opportunity to help develop constructive working relationships.

On the motion of Councillor Gordon, seconded by Commissioner Skelton, it was **agreed** to receive the bi-monthly Urban Development Strategy Implementation Report from the Independent Chair and the Implementation Manager.

#### 9. PROPOSED INITIAL TIMEFRAMES FOR A REVIEW OF THE URBAN DEVELOPMENT STRATEGY

The Committee noted that:

- the purpose of this report was to update on where work is currently at in this area .
- it is important to find out where population growth and related areas of pressure will be before . a full review takes place
- the outcome of the Judicial Review on the Ministerial Decision in relation to the Regional Policy Statement may influence the timeframes for this review.

On the motion of Councillor Gerard, seconded by Mayor Coe, the it was agreed:

- That given the current focus on recovery, a full review of the Urban Development Strategy a. (UDS) is not undertaken during 2012/13, but that instead any immediate re-evaluation of the UDS is undertaken as part of the collaborative development of recovery programmes.
- b. The initial timeframes for a programme reviewing the Urban Development Strategy (UDS):

- c. That the timeframes in Recommendation b. above, remain tentative and that a further report be brought back to the Committee in July 2013 to update on these timeframes.
- d. That the approach outlined in Recommendations (a) through (c) above, be reported back to the Urban Development Strategy partner council meetings for their ratification.

#### URBAN DEVELOPMENT STRATEGY IMPLEMENTATION MANAGEMENT GROUP WORK 10. PROGRAMME 2012/13

The Committee noted :

- the interim Urban Development Strategy Implementation Management Group 2012/13 work • programme outlined in this report
- the proposed approach to undertake a joint alignment and prioritisation process with the . Canterbury Earthquake Authority (CERA) to confirm an agreed UDS/CERA work programme going forward.

On the motion of Councillor Gerard, seconded by Councillor Lyall, it was agreed that the Committee will consider a further report on the Urban Development Strategy Implementation Management Group work programme, at its meeting in September or October 2012, once the joint prioritisation process is complete.

The Committee noted that future meetings of the CERA Advisory Committee and the UDSIC will be held in the Christchurch City Council Chamber and that the finishing time will be extended to 1 PM.
