NOTICES OF MOTION

1. CONFIRMATION OF PROCEEDINGS TO MAKE THE CHRISTCHURCH CITY TRAFFIC AND PARKING AMENDMENT BYLAW 2003

At its meetings on 11 December and 19 December 2003 the Council resolved:

- 1. To adopt the Statement of Proposal (in its unabridged form) and the Summary of Information in respect to the above proposed bylaw.
- 2. To include the statement of proposal on the agenda for the meeting of the Council on 26 February 2004.
- 3. That the statement of proposal (in its unabridged form) be made available for public inspection at all Council Service Centres, Council Libraries and on the Council's website.
- 4. That public notice of the proposal be given in 'The Press' newspaper and on the Council's website on Tuesday 23 December 2003.
- 5. That the summary of information be distributed by way of publication (together with public notice of the proposal) in 'The Press' newspaper and on the Council's website on Tuesday 23 December 2003.
- 6. That the period within which the submissions on the proposal may be made to the Council be between Tuesday 23 December 2003 and Friday 13 February 2004.
- 7. That all submissions on the proposal be heard by the Land Transport Subcommittee which shall report to the Council at its meeting on Thursday 26 February 2004.

Subsequent to publication of the Council agenda a small typographical error was discovered in the statement of proposal which is corrected in the resolution below.

Following the giving of public notice of the proposal to make the bylaw and the distribution of the summary of information, no submissions were received on the proposal. Consequently the Statement of Proposal is now included in the agenda for this meeting of the Council (refer Attachment 1) and the following resolution should therefore be adopted:

"The public notice required by the Local Government Act 2002 having been given in the Christchurch Press newspaper on Wednesday 24 December 2003, and no submissions having been received, the following resolution should be adopted:

That in pursuance of the powers vested in it by the Local Government Act 2002 and the Transport Act 1962, the Christchurch City Council resolves that the bylaw attached as Attachment 2, being the Christchurch City Traffic and Parking Amendment Bylaw 2003, now be made, subject to the deletion of the references in clause 4 to subparagraph numbers "(k)" and "(i)" and the substitution therefore of subparagraph numbers "(i)" and "(j)" and that the seal of the Council be affixed to the bylaw as appropriate.""

2. SPEAKING RIGHTS: VARIATIONS TO PROPOSED CITY PLAN

To consider the following motion, notice of which has been given by Councillor Anna Crighton pursuant to clause 2.16 of Standing Orders:

- 5. That the summary of information in relation to the proposed bylaw be distributed by way of publication (together with public notice of that proposal) in The Press newspaper and on the Council's website on Tuesday 23 December 2003.
- 6. That the period within which submissions on the proposed bylaw may be made to the Council be between Tuesday 23 December 2003 and Friday 30 January 2004.
- 7. That all submissions on the proposal be heard by the Dog Control Subcommittee which shall report to the Council at its meeting on Thursday 26 February 2004.
