#### COMMUNITY DEVELOPMENT

**Te Kupenga o Aranui, St Andrews House Community Trust and Ambrosia Empowerment Trust** - The Board noted that it fully supported the work that was done by the above organisations and the community development workers but it indicated that it may look to reduce the level of funding provided in future years.

**Out of School Programme Support** - The Board indicated that it would be looking for these organisations to be more self-sufficient in future years.

**Aranui Community Renewal** - The Board indicated that it would consider reducing the level of funding in future years.

**Burwood/Pegasus Community Watch** – The Board recommended that the group approach the New Brighton Club and pub charities as potential funding sources.

**Project K Canterbury** – The Board encourages the organisation to investigate sponsorship opportunities.

**SeniorNet New Brighton** – The Board referred this application to the Community Development Scheme. The Board also recommends that the organisation investigate coming under the umbrella of the New Brighton Club.

**Te Ropu Tamariki** – The Board indicated that it would consider reducing the level of funding in future years.

**Parklands Playcentre** – The Board referred this application to the Community Development Scheme. The Board also recommends that staff work with the organisation to investigate other funding sources, for example pub charities.

**Alan's Men**– The Board referred this application to the Metropolitan Community Development Scheme and Creative Communities Fund.

**Aranui Village Mission** – The Board referred the project courses in this application to the Community Development Scheme.

**The Southern Centre** – The Board referred this application to the Metropolitan Community Development Scheme.

**Collingwood Happi Club** – The Board referred this application to the Community Development Scheme.

**North Wai Boardriders Club** – The Board declined the application. The Board however, expressed a desire to see beach-based programmes and health and safety programmes provided for young people in the area. The Board agreed to provide a \$15,000 seeding grant for the Community Recreation Adviser to allocate to such programmes, upon application from programme providers like the North Wai Boardriders Club.

**United Fencing Club** – The Board referred this application to its Sport and Recreation Fund.

**Fono Faufautua Samoa** – The Board referred this application to the Metropolitan Community Development Scheme.

**Marshland Tennis Club** – The Board declined this application. The Board asked that the Club be informed that the Sport and Recreation Fund was available for specific projects, other than that applied for under this application.

**New Brighton Tae Kwon Do Club Trust** – The Board referred this application to its Sport and Recreation Fund.

Te Ropu Takaro Maori – The Board referred this application to its Sport and Recreation Fund.

**Surf Lifesaving Resources** – The Board requested a report on the level of Surf Lifesaving services provided on beaches in the Burwood/Pegasus area during the summer.

#### GREENSPACE

**Horseshoe Lake Reserve** – The Board declined the application for funding for community based weed removal and restoration work. The Board **resolved** to recommend that the Greenspace Unit carry out the weed removal and restoration work as part of its maintenance budget.

**New Brighton Beach Wheelchair and Access Mat** – The Board declined this application as it noted that it may be funded through other sources.

**Larnach Street Sand Shower**– The Board declined this application. The Board **resolved** to allocate \$500 for the provision of a shower at the Waimairi Surf Club if required.

**Junior Neighbourhood Support**– The Board declined this application. The Board noted that further information and research was required and it indicated that it might look favourably on a more comprehensive application next year.
