**2. DEPUTATIONS BY APPOINTMENT**

**2.1 Marshland Road Lane Marking**

Tony Mander, Ian Daniels, Ken Wilson and Ralph Ross (Shirley Residents' Association) addressed the Board regarding their concerns on the consultation process in relation to the Marshland Road lane marking project.

The Board **received** the information, noting the residents' concerns and decided that the Shirley/Papanui Community Board meet with the Burwood/Pegasus Community Board to discuss:

- (a) The consultation process in relation to the project;
- (b) The Council processes in addressing this issue now;
- (c) Additional parking for businesses in the area;
- (d) The need for pedestrian crossing facilities on Marshland Road; and
- (e) Any remedial actions which the Boards may take on behalf of their residents.
