PART B - REPORTS FOR INFORMATION

1. WELCOME

The Chairperson welcomed all present.

2. DEPUTATIONS BY APPOINTMENT

2.1 Inspector Dave Lawry

The Board welcomed the new Police Inspector for the Shirley/Papanui area, Inspector Dave Lawry.

2.2 Belfast Community Network

Lynda Goodrick, Belfast Community Network Co-ordinator, and the Rev. Sally Carter updated the Board on the activities of the Belfast Community Network and requested funding for storage containers.

The Board advised that resource consent might be required for the storage containers proposed to be located on the premises.

The Board **received** the information and requested a staff report on the application.

2.3 Styx Residents' Group

Phil Gourdie from the Styx Residents' Group spoke to the Board about the following issues on Barnes Road:

- * Poor street lighting.
- * Signage near the railway line was a problem for motorists and pedestrians.
- * Cul-de-sac off Barnes Road
- * Speeding
- * Dense foliage
- * Noise from the premises occupied by Chequer Packaging Ltd

The Board **received** the information and requested:

- (a) That staff report back to the Board in the form of a memo or a report on the traffic issues, street lighting, signage and width of the road.

- (b) That the Residents' Association be advised that the Parks and Waterways Area Advocate would be arranging for the trimming of the dense foliage.
- (c) That the concerns regarding speeding on Barnes Road be referred to the Police with a request that enforcement action be taken.

2.4 Belfast Residents' Association

Gavin Stanbury, from the Belfast Residents' Association, spoke to the Board about concerns regarding the median strip opposite the entrance to Englefield Road.

The Board **received** the information and requested that the Transport and City Streets Liaison Officer liaise with Transit NZ regarding the concerns raised on behalf of the Residents' Association and report back to the Board.

3. CORRESPONDENCE

3.1 Letter from Mr P J Tucker

The Board **received** a letter from Mr P J Tucker highlighting concerns about traffic problems on Northfield Road.

The Transport and City Streets Liaison Officer advised that he had asked the Network Operations Team to put traffic counters on Northfield Road and once the data was updated this would be reported to the Board.

The Board requested that the Transport and City Streets Unit write to Mr Tucker and the Principal of Casebrook School on progress.

3.2 Road Safety Fund

The Board **received** an email from the Road Safety Co-ordinating Committee seeking ideas from the Board for any community groups in their area which might have road safety projects they wished to carry out.

The Board suggested that the request for funding from the Waimairi School Principal raised at the meeting with the school principals be referred to the Road Safety Co-ordinating Committee.

3.3 Recent Government Announcements to assist Communities

The Board **received** a letter from the Minister of Local Government informing the Board about two recent Government decisions, which would assist people in local communities.

6. EVERGREEN CLUB – OLDER ADULTS RECREATIONAL INITIATIVE

The Board considered a report from the Community and Recreational Adviser seeking funding for an older adults recreational initiative.

The Board resolved that:

- (a) \$5,000 be allocated from the Board's 2004/05 discretionary funds to the Delta Community Support Trust for "The Evergreen Club" project, subject to the approval of other funding applications currently being made by the Delta Community Support Trust for this project.
- (b) That any surplus remaining from the funds allocated be returned to the Board.

7. HORNER STREET "P30" PARKING RESTRICTION

The Board considered a report seeking its approval to replace the "No Stopping" restriction with a 30 minute parking restriction.

The Board **resolved** that the Chairperson and Norm Withers be requested to meet with the author of the report to seek clarification of certain related consultation issues, and that they be delegated power to make a final decision in respect of the installation or otherwise of the 30 minute parking restriction proposed.
