### 1. MINUTES OF THE PREVIOUS MEETING

The minutes of the previous meeting of 15 August 2005 were received.

# 2. FORUM PRESENTATION IN RELATION TO SCOPE, STRUCTURE, PROJECT DOCUMENT

Prior to the PowerPoint presentation on this matter, the Chairman provided an overview of the situation covering:

- Phase 2 of the project has now been commenced
- There had been an enormous response to the options put out to the public
- A very uniform response had been received
- Mark Bachles, Project Team Leader, had taken up a new job opportunity in Australia
- It was now an opportunity to relook at the structure

In determining "Where to from here" the Forum could:

- Look at the plan
- Look at the structure (including changes brought forward by staff to achieve outcomes)
- A plan for the future

#### **PowerPoint Presentation**

Members of the Project Team provided a PowerPoint presentation covering:

- Where are we at
- Need to redefine the process
- Process to date gives a better idea where we are heading
- Recommended project structure
- Work stream
- Process
  - Vision
  - Community charter
  - Melbourne charatte metro area
  - Charatte elements
  - Work stream framework
  - Financial and timing implications

In regard to this point, Carolyn Ingles advised that an additional \$400,000 was required to that already budgeted, to enable the programme to be carried out. Using the 2004 formula basis, it would be split amongst the contributing authorities as follows:

Christchurch City Council	\$250,000
Environment Canterbury	\$80,000
Waimakariri District Council	\$30,000
Selwyn District Council	\$30,000
Banks Peninsula District Council	\$10,000

It was noted that Christchurch City Council has already contributed a further \$150,000.

In the discussion that followed, members commented or questioned the following:

- The reasons for the structure proposed
- Whether having the CEOs group was appropriate
- Whether there would be a vision for the whole greater city first or individual components would be brought together to form a vision
- Whether there was a move away from the March 2004 document which in the working groups referred to hospitals, schools etc
- Whether there was a need to have separate work stream groupings at all
- The position of CRETS in relation to where it stood with the UDS
- The need to ensure the proper resources were available to carry out the various studies etc
- The individual commitment local authorities would need to give to the preparation of some area plans
- The difficulties of the budget in respect of timing
- The need for the community charter to be available in early 2006
- The need to ensure the proper framework is in place when UDS next goes out to the community

#### **Resolved:**

That the Forum continue the approach as outlined in the Scope, Structure, Project document.

It was noted that:

- The proposed changes would need to go back to each local authority for approval and incorporation into the relative documents
- The need for community groups to be informed on progress
- The names of the staff team leaders etc to be advised in due course
