NOTES OF A JOINT SEMINAR MEETING OF THE CHRISTCHURCH CITY COUNCIL AND HAGLEY/FERRYMEAD COMMUNITY BOARD

1. CITY MALL REVITALISATION PROGRAMME

Jane Parfitt, General Manager City Environment, introduced the seminar referring to the scale of the project and its various components.

There followed a PowerPoint presentation given by the representatives from the Isthmus Group. They commented that the project would put a 'heart and soul' into the city, not just bricks and mortar. Their presentation covered:

QUESTIONS AND COMMENTS

The Mayor, in opening the discussion, referred to the huge opportunity the project provided. It was a chance to engage with other sectors, today being the start of a process.

Other comments made included:

- Where did Community Boards fit in?
- What were the differences between preferred option and the other options?
- What did the feedback from the people using and shopping in the area say?
- What was planned for Hereford Street, given that it didn't seem to work that well?
- A special presentation to all Community Boards was requested.
- The Council needed to work with WINZ to change its building frontage.
- Clarification was sought on what was meant by movement corridor.
- The cost of extending the tram service was questioned and whether the tram lines should be installed irrespective.
- There was nothing to show how the buses would disappear off Colombo Street.
- There was limited space left outside the Hallensteins building for activities that currently took place there (ie where were the people going to sit?).
- What sort of numbers did the city have to attract to the area to make it work?
- Was the budget sufficient for the project?
- Which were the work priorities?
- Was the tram to be used mainly for the tourist trade, or as a shuttle?
- Should we have an eye to the future and cover the whole area?
- More colour planting was required.
- The mall area needed to be warmed up by reducing the prevailing wind etc.
- Colombo Street could not be improved until the bus situation was solved.
- While the 3D visual was excellent, to really sell the idea a model needed to be made and displayed.
- Were more grass lawns required?
- Should there be an east to west shuttle service as opposed to using trams?
- Were the young people's ideas for skate parks, basketball hoops, etc, being taken into consideration?
- A review of the signs littering the walkways etc, needed to be made.
- What will cause a buy-in from the property owners?
- Could the boy-racers in Colombo Street be controlled?
- There are eight schools, including three high schools, within the area to be taken into account.
- The area was undesirable during the winter period.
- Roof-top gardens etc where people could 'chill-out' should be provided.
- Why were more roads being considered?
- The alleyways were not safe for visitors and needed to be better lit.

OUTCOME

Jane Parfitt summarised the main points emerging as being:

- 1. Presentation to be made to all Community Boards.
- 2. The WINZ building facade needed to be discussed with the building's owner.
- 3. Name?
- 4. Attention to be paid to vistas.

- 5. Height of buildings allowed in the area to be examined.
- 6. The proposal to be put out for consultation will be based on the presentation.
- 7. The project will provide a heart and soul to the area.
- 8. Extension to the tram service will be incorporated in the project.

The Council will get to sign off on the proposal going out for consultation and a hearings panel would need to be appointed.

The seminar concluded at 12.15pm.
