PURPOSE OF REPORT

1. The purpose of this report is to seek the Council's confirmation to the appointment of two external representatives to the Audit and Risk Management Subcommittee and to note a small amendment to the schedule of appointments to subcommittees made by the Council at its meeting on 13 December 2007.

EXECUTIVE SUMMARY

- 2. At its meeting on 13 December 2007 the Council appointed Councillors Cox, Shearing, Sheriff, Withers and the Mayor to the Audit and Risk Management Subcommittee and reconfirmed the terms of reference for the Subcommittee.
- 3. In the previous term of the Council the Audit and Risk Management Subcommittee also comprised two external representatives, Messrs John Hooper and Michael Rondel, who were appointed to this Subcommittee by the Council at its meeting on 15 December 2005.
- 4. The Council had previously at its meeting on 16 June 2005 decided that two external appointees with experience in financial/risk management be appointed to the Subcommittee and Messrs Rondel and Hooper were chosen from a shortlist of possible candidates and appointed for their extensive experience in audit management and risk processes.
- 5. Mr Hooper is the Associate Senior Partner with BDO Spicers and Mr Rondel is Associate, Assurance and Business Consulting Services, at Poulson Higgs, Christchurch.
- 6. It is considered desirable that both Mr Hooper and Mr Rondel be reappointed to the Audit and Risk Management Subcommittee in view of their knowledge, experience and the contribution they have made over the past two years to the work of the Subcommittee.
- 7. It is also requested that the Council note for completeness a small amendment to the composition of the Creative Communities Funding Subcommittee as detailed in clause 2 of the staff recommendation.
