1. KENNEDYS BUSH DEVELOPMENT

It was explained that the purpose of the Seminar was to enable the various parties, City Council, Developers and Residents' Associations to discuss in an informal manner details of the proposed private plan change and the issues arising from this.

A proposal put forward by a consortium of Kennedys Bush Developments Limited, Lansdowne Farm (2005) Limited and Rossendale Holdings Limited was for 208 quality, low density, high value homes set amongst reserves of native bush and adjoining 190 hectares of parkland. This would link by a series of pathways to the Summit and to other reserves on the Port Hills

The Park itself containing 190 hectares reached to the Summit and provided easy access for the public via two routes.

Kennedys Bush Residents' Association

Sylvia Lukey referred to the importance of the Port Hills in both a national and regional perspective.

Halswell Quarry Park was an area to be proud of, the residents held regular working bees there. She questioned the reasons for having this seminar, suggested that any matters related to environmental compensation should be considered by the new Council.

Lansdowne Valley Residents' Association

Ian Duff on behalf of the Lansdowne Valley Residents referred to the proposal as being rehash of earlier proposals by Kennedys Bush Development Limited, which was rejected by the Environment Court in 2004.

He went on to point out the similarities, essential differences between the proposals before referring to what he saw as an essential problem with environmental compensations.

Lansdowne Valley Residents' Association

Paul Sintes on behalf of the Lansdowne Valley Residents Group referred to the land being offered as compensation, as being a piece of gorse and broom covered wasteland which would cost \$1.23m to convert to native replanting.

He saw the KBP proposal as destroying the most outstanding areas of existing natural hill landscape in the Valley.

Outcomes

The opportunity was taken to seek clarification on the various matters put forward by the different parties, it being noted that the Selwyn District Council was involved and its perspective should be obtained.

In due course the proposal would come before the Council and due process would take place.

The seminar concluded at 3.32pm.
