A meeting of the Alcohol Policy and Liquor Control Bylaw Subcommittee was held on 6 August 2008 at 1pm

1. ALCOHOL POLICY AND LIQUOR CONTROL BYLAW MATTERS

It was reported that the focus for the meeting was the areas the bylaw might cover, as suggested by the New Zealand Police, Councillors and Community Board members.

A report dated 6 August 2008 was tabled which covered:

- Background/Summary of the potential coverage of the liquor ban bylaws
- Analysis required for bylaws generally
- Outcome/Recommendations on whether or not to proceed with further analysis on possible liquor ban areas.

Particular attention was drawn to the bylaws having:

- Limitations in terms of coverage
 - Only council-controlled land, not private land
 - Only the consumption or possession of alcohol, not behaviour arising from alcohol
- Must be reasonable (Bylaws Act) and not give rise to implications under the Bill of Rights Act
- Section 155 Analysis requirements under the Local Government Act.

A variety of questions or comments were made in respect of these:

- The need to look at the affect of the Bill of Rights
- The provision of evidence regarding the appropriateness of imposing a ban
- What would be the affect if there was no ban in place?
- Were there other things happening such as public safety?
- Could there be a ban citywide covering public places?
- Signage requirements and cost implications
- Would the problem just shift from one area to another?

It was agreed that some areas be confirmed as needing a full section 155 analysis, and that other areas needed further initial analysis and advice before the Subcommittee could decide if a full section 155 analysis was needed.

The Subcommittee was advised that a member of the New Zealand Police was now part of the staff team working on the liquor ban bylaw, Senior Sergeant Richard Bruce.

1. PROSTITUTION REFORM ACT 2003 AND BROTHELS BYLAWS
