Following the hearing of the submissions, the Subcommittee concluded that in view of the unreasonable disruption to the objectors' operations which would result from the closure of Rue Lavaud, it would be preferable for the race to finish at the point in Woodills Road east of Rue Lavaud used as the finishing point for Le Race 2007.

The Subcommittee also noted the race organiser's advice that she would no longer require the affected section of Beach Road to be closed off for prizegiving and related activities.

## The Subcommittee therefore **resolved** to:

- 1. Allow the objections to the proposal to close Rue Lavaud from Woodills Road to a point midway between Rue Viard and Rue Brittan/Rue Pompallier between 9am and 3pm on Saturday 29 March 2008
- 2. Also allow the objection to the closure of Beach Road between Church Road and Rue Jolie between 1pm and 7pm on the same date.
