11. PROPOSED GIVE WAY SIGNS

 WAVERLEY STREET, HUTCHESON STREET, HASTINGS STREET WEST, WALTON STREET, WOODBRIDGE STREET, WHERSTEAD ROAD, THORRINGTON ROAD, NUTFIELD LANE, ERNLEA TERRACE, AYLMER STREET, BOON STREET, DEVON STREET, ANGUS STREET, FISHER AVENUE, SOUTHEY STREET, ROXBURGH STREET

The Board considered a report seeking approval for Give Way signs to be placed on the intersections of Colombo Streets and Waverley Street, Hutcheson Street, Hastings Street West, Walton Street, Woodbridge Street, Wherstead Road, Thorrington Road, Nutfield Lane, Ernlea Terrace, Aylmer Street, Boon Street, Devon Street, Angus Street, Fisher Avenue, Southey Street, Roxburgh Street.

The Board **resolved** to approve to the placement of a Give Way Sign against:

- (a) Waverley Street at its intersection with Colombo Street
- (b) Hutcheson Street at its intersection with Colombo Street
- (c) Hastings Street West at its intersection with Colombo Street
- (d) Walton Street at its intersection with Colombo Street
- (e) Woodbridge Street at its intersection with Colombo Street
- (f) Wherstead Road at its intersection with Colombo Street
- (g) Thorrington Road at its intersection with Colombo Street
- (h) Nutfield Lane at its intersection with Colombo Street
- (i) Ernlea Terrace at its intersection with Colombo Street
- (j) Aylmer Street at its intersection with Colombo Street
- (k) Boon Street at its intersection with Colombo Street
- (I) Devon Street at its intersection with Colombo Street
- (m) Angus Street at its intersection with Colombo Street
- (n) Fisher Avenue at its intersection with Colombo Street
