**9. CONFIRMATION OF MINUTES – 4 NOVEMBER 2009**

The Board **resolved** that the minutes of the Board's ordinary meeting of 4 November 2009 be confirmed.

**10. FITZGERALD AVENUE – PROPOSED P10 PARKING RESTRICTION**

The Board considered a report seeking approval that a parking restriction be installed on the east side of Fitzgerald Avenue.

The Board **resolved** to approve that the parking of vehicles be restricted to a maximum period of 10 minutes on the eastern side of Fitzgerald Avenue commencing at a point 36 metres south from its intersection with London Street, and extending in a southerly direction for a distance of 12 metres.

**11. 127 ENSORS ROAD – PROPOSED NO STOPPING RESTRICTION**

The Board considered a report seeking approval that the stopping of vehicles be prohibited at any time on a section of the western side of Ensors Road.

The Board **resolved** to approve:

- (a) That the stopping of vehicles be prohibited at any time on the western side of the northern carriageway of Ensors Road commencing at a point 30 metres north of its intersection with the northern-most track of the eastbound Christchurch to Lyttelton Railway Line and extending in a northerly direction for a distance of 15 metres.
- (b) That the stopping of vehicles be prohibited at any time on the western side of the northern carriageway of Ensors Road commencing at a point 66.5 metres north of its intersection with the northern most track of the eastbound Christchurch to Lyttelton Railway Line and extending in a northerly direction for a distance of 9 metres.
