**SHIRLEY/PAPANUI COMMUNITY BOARD  
7 OCTOBER 2009**

**Minutes of a meeting of the Shirley/Papanui Community Board,  
held on Wednesday 7 October 2009 at 4pm  
at Rehua Marae, 79 Springfield Road, St Albans  
and on Monday 12 October 2009 at 5pm  
in the Boardroom, Papanui Service Centre, corner Langdons Road and Restell Street, Papanui.**

**PRESENT:** Yvonne Palmer (Chairperson), Ngaire Button, Kathy Condon, Pauline Cotter, Aaron Keown, Matt Morris, and Norm Withers.

**APOLOGIES:** An apology for lateness was received and accepted from Matt Morris, who joined the meeting at 4.03pm on 7 October 2009.

Apologies for absence were received and accepted from Aaron Keown and Norm Withers on 12 October 2009.

The meeting adjourned at 6.30pm on Wednesday 7 October 2009 and resumed at 5pm on Monday 12 October 2009.

The Board reports that:

**PART B - REPORTS FOR INFORMATION**

**1. DEPUTATIONS**

**1.1 MR JH PARRETT – SISSON PARK TREE REMOVAL REQUEST**

Mr Parrett of 33 Brogar Place, tabled and spoke on his support for the tree removal petitioned for by Mr and Mrs McCormack. He shared their concerns about shading and Alder tree debris. Mr Parrett introduced new information in support of the tree removal – it was his opinion that there was flooding during wet weather of the Applewood Place end of the park; there was a danger of tree roots leaching gardens of nutrients, causing drainage pipe damage, sewerage pipe damage, uplifting concrete paths and is the cause of house foundation cracks in some cases. Mr Parrett also advised he had a photograph showing the adverse effect of shading on his property from the eucalypt.

The Chairperson thanked Mr Parrett for his deputation. This matter was considered by the Board in clause 7.

**1.2 RALPH ROSS (SHIRLEY RESIDENTS' ASSOCIATION – QUINNS ROAD SAFETY IMPROVEMENTS**

Ralph Ross outlined his safety concerns with the proposed placement of the speed humps in Quinns Road and in particular the one recommended outside of 192 and opposite 181 Quinns Road. Mr Ross requested that the hump be placed on the bend opposite section 177 so as to improve the line of sight from either direction. Mr Ross also requested consideration be given for the school crossing point being installed on the bend outside the school to improve visibility.

The Chairperson thanked Ralph Ross for his deputation. This matter was considered by the Board in clause 8.

**5. CORRESPONDENCE**

The Board **received** the following correspondence:

- 5.1 A letter from Gavin Royfee requesting No-Stopping lines on the bend in Stapletons Road outside numbers 126 and 128 Stapletons Road.

It was **decided** to request a report from staff on the proposed installation of No-Stopping lines on the east side of Stapletons Roads on the bend by 126 and 128 Stapleton Road in the interest of safety.

**PART C - DELEGATED DECISIONS TAKEN BY THE BOARD**

**6. CONFIRMATION OF MINUTES – BOARD MEETING OF 16 SEPTEMBER 2009**

The Board **resolved** that the minutes of its ordinary meeting held on 16 September 2009, both open and public excluded, be confirmed.

**7. SISSON PARK – TREE REMOVAL REQUEST**

The Board considered a report seeking removal of four trees (three alders and a eucalyptus) from Sisson Park, Casebrook.

Aaron Keown moved that all the four trees identified in the agenda be removed.

The motion was seconded by Pauline Cotter.

Yvonne Palmer moved an amendment that the matter lay on the table until more information is received on the damage caused by the alder's roots, the effects of the eucalyptus shading and also the cause of the flooding in the park.

The amendment was seconded by Matt Morris and when put to the meeting was declared **lost** on division No. 1 by 4 votes to 3, the voting being as follows:

**Against (4):** Ngaire Button, Pauline Cotter, Aaron Keown and Norm Withers.

**For (3):** Kathy Condon, Matt Morris and Yvonne Palmer.

Norm Withers moved the following amendment:

- (a) That the Board approve the removal of the two alders only (outside Mr McCormack's property) from Sisson Reserve and charge the applicants for the cost of replacement, with all work to be undertaken by the Council's park tree contractor.

- (b) That the Board request more information regarding the eucalyptus and the third alder, including damage to the footpath and the tree-shading photograph mentioned by Mr Parrett during his deputation.

The amendment was seconded by Ngaire Button and when put to the meeting was declared tied 3 all on division No. 2 with 1 abstention, the voting being as follows:

**For (3):** Ngaire Button, Pauline Cotter and Norm Withers.

**Against (3):** Kathy Condon, Matt Morris and Yvonne Palmer.

**Abstained (1):** Aaron Keown.

The Chairperson used her casting vote against the motion and the motion was declared **lost**.

The original motion moved by Aaron Keown was then considered.

Ngaire Button moved an amendment that the matter of the Sisson Park Tree Removal Request lay on the table pending receipt of further information around the costing of tree replacement, reported adverse effects of shading, effect of tree roots on property and footpaths and the photograph from Mr Parrett illustrating the effect of shading on his property.

The amended motion was seconded by Kathy Condon and when put to the meeting was declared **carried** as the substantive motion.

## 8. QUINNS ROAD SAFETY IMPROVEMENTS

The Board considered a report seeking approval for the proposed Quinns Road Safety Improvement to proceed to detailed design, tender and construction and to approve associated parking restrictions.

Staff addressed the concerns raised by Mr Ralph Ross in his deputation at clause 1.2. The positioning of road humps were based on traffic engineering advice and took advantage of existing street lighting and motorist's line of sight from both directions.

The Board **resolved:**

- (a) To approve the Quinns Road Safety Improvement Project for detailed design, tender and construction as shown on the plan appended to the agenda.
- (b) The following parking restrictions:

### **Revocation of existing parking restrictions:**

- (i) That any existing parking restrictions at any time on the west side of Quinns Road commencing at its intersection with Hammersley Avenue and extending 50 metres in a northerly direction be revoked.
- (ii) That any existing parking restrictions at any time on the east side of Quinns Road commencing at its intersection with Hammersley Avenue and extending 50 metres in a northerly direction be revoked.
- (iii) That any existing parking restrictions at any time on the east side of Quinns Road commencing at its intersection with Voss street and extending 50 metres in a southerly direction be revoked.
- (iv) That any existing parking restrictions at any time on the east side of Quinns Road commencing at its intersection with Voss street and extending 50 metres in a northerly direction be revoked.

- (v) That any existing parking restrictions at any time on the north side of Voss Street commencing at its intersection with Quinns Road and extending 50 metres in an easterly direction be revoked.
- (vi) That any existing parking restrictions at any time on the south side of Voss Street commencing at its intersection with Quinns Road and extending 50 metres in an easterly direction be revoked.

**New no stopping:**

- (vii) That the stopping of vehicles be prohibited at any time on the west side of Quinns Road commencing at its intersection with Hammersley Avenue and extending 30 metres in a northerly direction.
- (viii) That the stopping of vehicles be prohibited at any time on the east side of Quinns Road commencing at its intersection with Hammersley Avenue and extending 30 metres in a northerly direction.
- (ix) That the stopping of vehicles be prohibited at any time on the east side of Quinns Road commencing at a point 166 metres north of its intersection with Hammersley Avenue and extending 18 metres in a northerly direction.
- (x) That the stopping of vehicles be prohibited at any time on the east side of Quinns Road commencing at its intersection with Voss Street and extending 15 metres in a northerly direction.
- (xi) That the stopping of vehicles be prohibited at any time on the east side of Quinns Road commencing at its intersection with Voss Street and extending 10 metres in a southerly direction.
- (xii) That the stopping of vehicles be prohibited at any time on the north side of Voss street commencing at its intersection with Quinns Road and extending 24 metres in an easterly direction.
- (xiii) That the stopping of vehicles be prohibited at any time on the south side of Voss street commencing at its intersection with Quinns Road and extending 18 metres in an easterly direction.

(Note: Aaron Keown voted against the resolution on the grounds of design and the lack of an estimated cost of the project in the report.)

**9. REQUEST FOR FUNDING - SHIRLEY COMMUNITY TRUST**

The Board considered a report seeking funding from the Board's Discretionary Response Fund for the Shirley Community Trust to assist with the costs of staging a Shirley Light Party as a Halloween alternative on 31 October 2009.

The Board **resolved** to approve a grant of \$600 from the 2009/10 Discretionary Response Fund to the Shirley Community Trust to assist with the costs of staging the Shirley Light Party on 31 October 2009.

**10. YOUTH DEVELOPMENT SCHEME – THOMAS TUUTA**

The Board considered a report seeking funding from the Youth Development Scheme for Thomas Tuuta to enable him to purchase equipment related to his education into Maori and Pacific Island tattooing principles and practice.

**10 Cont'd**

The Board **resolved**:

- (a) To decline the grant funding application of \$580 from Thomas Tuuta to enable him to purchase equipment related to his education into Maori and Pacific Island tattooing principles and practice.
- (b) That the Chairperson and Deputy Chairperson advocate to Mark Solomon of Ngai Tahu for that group to consider assisting Thomas Tuuta to enable him to purchase equipment related to his education into Maori and Pacific Island tattooing principles and practice.

**11. CRIMEWATCH (CHRISTCHURCH) INCORPORATED**

The Board considered a report requesting joint funding from the Board's Discretionary Response Fund and the Fendalton/Waimairi Community Board for Crimewatch (Christchurch) Incorporated for \$1,250 each for the provision of signage on their cars.

Staff provided information that the Fendalton/Waimairi Community Board's Community Services Committee had, that day, recommended to their Board approval of the requested expenditure.

The Board **resolved** to allocate, from its 2009/10 Discretionary Response Fund, a grant of \$1,250 to Crimewatch (Christchurch) Incorporated to help with the costs of signage for their cars.

(Note: Yvonne Palmer declared a conflict of interest and took no part in the discussion or voting on this item. Pauline Cotter assumed the chair for this item.)

**12. MARIAN COLLEGE ENVIRONMENT GROUP**

The Board considered a report requesting joint funding from the Board's Discretionary response Fund and the Burwood/Pegasus Community Board for the Marian College Environment Group for \$611 for the purposes of developing a vegetable garden.

The Board **resolved** to allocate \$300 from its 2009/10 Discretionary Response Fund to Marian College as a one-off grant to help with the Marian College Environment Group establishing a vegetable garden.

(Note: Yvonne Palmer voted against the resolution.)

**13. PROPOSED GIVE WAY SIGNS ON SIDE ROADS OF PAPANUI ROAD AND MAIN NORTH ROAD - MAYS ROAD, TOMES ROAD, PAPAROA STREET, PERRY STREET, DORMER STREET, BLAIR AVENUE, FRANK STREET, WYNDHAM STREET, WINSTON AVENUE, LOFTUS STREET, PROCTOR STREET, SHEARER AVENUE, APOLLO PLACE, MEADOW AVENUE**

The Board considered a report seeking approval a Give Way signs be placed against 14 intersections which are the subject of the Papanui Road/Main North Road bus priority project.

  - (h) Winston Avenue at its intersection with Main North Road
  - (i) Loftus Street at its intersection with Main North Road
  - (j) Proctor Street at its intersection with Main North Road
  - (k) Shearer Avenue at its intersection with Main North Road
  - (l) Apollo Place at its intersection with Main North Road
  - (m) Meadow Avenue at its intersection with Main North Road.
- (b) That a Stop Sign being placed against Wyndham Street at its intersection with Papanui Road because of the proximity of the Horner Street bend.

(Note: Aaron Keown voted against the resolution.)

Staff advice was given that a Stop Sign at the T-intersection on Wyndham Street and Papanui Road could create a dangerous precedent.

**14. PROPOSED GIVE WAY SIGNS – GRESFORD STREET, GUILD STREET, HENDON STREET, WARDEN STREET**

The Board considered a report seeking approval that a Give Way sign be placed against four intersections with Hills Road, which is the subject of the Queenspark bus priority project.

The Board **resolved** that a Give Way Sign be placed against:

- (i) Gresford Street at its intersection with Hills Road
- (ii) Guild Street at its intersection with Hills Road
- (iii) Hendon Street at its intersection with Hills Road
- (iv) Warden Street at its intersection with Hills Road.

**15. SHIRLEY/PAPANUI COMMUNICATION WITH THE COMMUNITY**

The Board considered a report requesting the allocation of up to \$5,200 from the 2009/10 Discretionary Response Fund to publish articles in local community newspapers which promote local Community Board information.
