PART A - MATTERS REQUIRING A COUNCIL DECISION

1. AKAROA/WAIREWA STRENGTHENING COMMUNITIES FUNDING 2010/11



PURPOSE OF REPORT

1. For the Council to consider a recommendation from the Akaroa-Wairewa Community Board that the unsubscribed portion of the Akaroa-Wairewa Strengthening Communities Fund, being \$12,765, be transferred so that it could be allocated under the Akaroa/Wairewa Small Grants Fund.

EXECUTIVE SUMMARY

2. The Akaroa/Wairewa Strengthening Communities Fund for 2010/11 had a total pool available of \$29,865. At its meeting on 7 July 2010, the Board allocated \$17,100 of that pool. Staff advised that applications to the Small Grants Fund for Akaroa/Wairewa exceeded the available pool in that fund, and that if the Board wished to do so, it could apply to the Council to have the unallocated Strengthening Communities funds transferred to the Small Grants Fund.
3. The Board was satisfied that the transfer of the funds was a practical suggestion for the dissemination of Strengthening Communities funds in the Akaroa-Wairewa community.

FINANCIAL IMPLICATIONS

4. The transfer of funds would increase the Akaroa/Wairewa Small Grants Fund 2010-11 by \$12,765, from \$6,826 to \$19,591.
