**10. ST ALBANS STREET OUTSIDE NO 147/149 – PROPOSED NO STOPPING RESTRICTION**

The Board considered a report seeking approval that the stopping of vehicles be prohibited at any time on the north side of St Albans Street, west of Rutland Street.

**STAFF RECOMMENDATION**

To formalise the Board's resolution it is recommended that the Shirley/Papanui Community Board:

**Revoke the following parking restriction:**

- (a) That any existing parking restrictions at any time on the north side of St Albans Street between its western intersection with Rutland Street and a point 19 meters west be revoked.

**Approve the following on St Albans street:**

- (b) That the stopping of vehicles be prohibited at any time on the north side of St Albans commencing at the western intersection with Rutland Street and extending in a westerly direction for a distance of 34 metres.

**BOARD DECISION**

Yvonne Palmer moved that the staff recommendation be declined. The motion was seconded by Kathy Condon and when put to the meeting was declared **carried** on division No. 1 by 4 votes to 2, the voting being as follows:

**For (4):** Ngaire Button, Kathy Condon, Yvonne Palmer and Norm Withers.

**Against (2):** Pauline Cotter and Aaron Keown.

The Board noted that staff have undertaken to discuss the issue of safe vehicle entry to and exit from 147 St Albans Street with the occupier and to consider installing a parking limit line at this location.

**12. APPLICATIONS TO SHIRLEY/PAPANUI COMMUNITY BOARD 2010/11 DISCRETIONARY RESPONSE FUND – PAPANUI HIGH SCHOOL AND PAPANUI SOFTBALL CLUB**

The Board considered a report seeking funding from its 2010/11 Discretionary Response Fund from Papanui High School, who were requesting \$5,000 and Papanui Softball Club who were requesting \$16,976.

The Board **resolved:**

**(a) Papanui High School:**

- (i) That the matter of the resurfacing of the two netball courts at Papanui High School lay on the table pending approval of the plans by Canterbury Hockey to ensure the design would meet their Junior Hockey requirements.
- (ii) Assurance from Papanui High School that the two netball courts at Papanui High School would be made available for public use free of charge out of school hours.

- (f) To approve a grant of \$150 from its 2010/11 Youth Development Fund to Christopher John Case to represent Canterbury as part of the under 17 Action Cricket Junior Provincials competition being held in Wellington from 27 September to 1 October 2010.

**15. MEMBERS' INFORMATION EXCHANGE CONT'D**

The Board **resolved** to approve a grant of \$94.78 from its 2010/11 Discretionary Response Fund to The Advertising Club as payment for the installation of a dedication plaque at the Papanui Youth Centre, noting this cost had been overlooked when on 7 February 2007 the Board approved funding to enable a kitchen to be included in the Papanui Youth Centre.
