The Board **resolved** that the report of its ordinary meeting (both open and public excluded) of Tuesday 18 May 2010, be confirmed.

10. MOBILE LIBRARY SERVICE - INSTALLATION OF PARKING RESTRICTIONS

The Board was requested to consider installing parking restrictions to provide the Council's Mobile Library Service vehicles with a consistent stopping place at each designated stop.

The Board **resolved** to approve the placement of mobile library stops at the locations detailed below:

- (a) That a bus parking space restricted to Mobile Library vehicles only on Tuesdays from 1pm to 3pm, be installed on the southern side of Merrin Street commencing at a point 96 metres south east of Withells Road and continuing in a south-westerly direction for a distance of 20 metres as Attachment 1 of the agenda report.
- (b) That a bus parking space restricted to Mobile Library vehicles only on Tuesdays from 2pm to 4pm, be installed on the western side of Cutts Road commencing at a point 35 metres west of Wyatt Place and continuing in a westerly direction or a distance of 20 metres as Attachment of the agenda report.
