8. RICCARTON/WIGRAM COMMUNITY SERVICES MEETING REPORT – 16 MARCH 2010

8.1 APPLICATION TO THE RICCARTON/WIGRAM 2009/10 YOUTH DEVELOPMENT SCHEME –JAYVEE TABANAS BUCHANAN

- 10.3 **Canterbury Community Justice Panels** - The Board noted that the Police have advised that the Department of Justice are considering instigating Community Justice Panels to deal with low level offences. Information will be distributed to Board members.

The Board was advised on the current balance of the Youth Development Scheme. Sufficient information was provided by staff to enable the Board to make the following resolution:

The Board **resolved** that \$500 be transferred to Riccarton/Wigram 2009/10 Youth Development Scheme from the Riccarton/Wigram 2009/10 Discretionary Response Fund.

14. RICCARTON/WIGRAM TRANSPORT AND GREENSPACE COMMITTEE MEETING REPORT - 22 MARCH 2010

The Board **received** the report of the Transport and Greenspace Committee meeting of 22 March 2010 and **resolved:**

14.1 REMOVAL OF TREE HUT FROM TEMPLETON DOMAIN

That the tree hut built by resident within the Templeton Domain be removed.

14.2 TEMPLETON DOMAIN MANAGEMENT PLAN

Clause 2 (Part A) of this report refers.

14.3 PROPOSED PARKING RESTRICTION – SCHOOL ROAD, HALSWELL

(a) To Revoke:

(i) All existing parking restrictions on School Road, Halswell.

(b) To Approve:

(i) That the stopping of vehicles be prohibited at all times on the northern side of School Road, Halswell commencing at its intersection with Larsons Road and extending in an easterly direction for a distance of nine metres.

(ii) That the stopping of vehicles be prohibited at all times on the northern side of School Road, Halswell commencing at a point 88 metres east of its intersection with Larsons Road and extending in an easterly direction for a distance of 28 metres.

- (iii) That a Bus Stop be installed on the northern side of School Road, Halswell commencing at a point 52 metres in an easterly direction from its intersection with Larsons Road and extending in an easterly direction for a distance of 36 metres.
- (iv) That the parking of vehicles be restricted to a maximum period of three minutes on the northern side of School Road, Halswell commencing at a point 116 metres east of its intersection with Larsens Road and extending in an easterly direction for a distance of 50 metres. This restriction is to apply between 8.30am to 9.30am and 2.30pm to 3.30pm on school days.

14.4 PROPOSED NO STOPPING RESTRICTION - PRINCESS STREET

- (a) That any existing parking restrictions at any time on the southern side of Princess Street within the distance at 12 metres east or west of Knight's Place be revoked.
- (b) That the stopping of vehicles be prohibited at any time on the south side of Princess Street commencing at its intersection with Knight's Place and extending in a westerly direction for a distance of 12 metres.
- (c) That the stopping of vehicles be prohibited at any time on the south side of Princess Street commencing at its intersection with Knight's Place and extending in an easterly direction for a distance of 12 metres.

14.5 REQUEST TO REMOVE SILVER BIRCH STREET TREE – JAMELL PLACE

That the remaining Silver Birch in the berm adjoining Mr and Mrs Scandrett's residence in Jamell Place be removed and replaced. The cost of removal and replacement to be a PB95 grade tree and to be at the expense of the Scandretts. The replacement tree will be outside 12 Jamell Place.

The meeting concluded at 6.14pm.
