6. COMMUNITY BOARD ADVISER'S UPDATE

- 6.1 **Sale of Liquor Application 150 Yaldhurst Road** - The Board were advised that the Liquor Licensing Agency has confirmed that it has received the Board's request to appear before them under section 108(e) of the Sale of Liquor Act. Refer to clause 17 of these minutes.
- 6.2 **Templeton Chapel of the Holy Family Community Trust Representative** - At the 5 July 2011 Board meeting the Board requested staff to seek further information on the representation role. The information was provided by memorandum to the Board and the decision on this matter is noted in clause 17 of these minutes.

7. ELECTED MEMBERS' INFORMATION EXCHANGE

- 7.1 **New Zealand Indian Central Association Inc** – The Board were advised that the New Zealand Indian Central Association Inc, through fundraising and donations by the community, have donated approximately \$34,000 to the Christchurch Mayoral Welfare Fund to assist with earthquake relief.

The Board acknowledged the Association for their generous donation.

- 7.2 **Templeton Domain Sportsground Lighting** – The Board requested staff to provide advice on getting lights installed and operating at the Templeton Domain to enable sports clubs to train.
- 7.3 **Westmorland Reserve** – Board members advised that the residents surrounding the reserve have requested that the geese population be culled.
- 7.4 **Upper Riccarton Library** – the Board were advised that Mike Mora and Peter Laloli attended the Riccarton High Board of Trustees meeting to discuss the matter of when the Council staff would be vacating the library to enable the school to fully use the library. The Board were advised that the library will be fully operational in Term One of 2012. The Board congratulated the staff on their work to make this possible.

The Board **resolved**:

- (a) That all existing parking restrictions the east side of Waimairi Road commencing at its intersection with Riccarton Road and extending in a northerly direction for a distance of 181 metres be revoked.
- (b) That the stopping of vehicles be prohibited at any time on the east side of Waimairi Road commencing at its intersection with Riccarton Road and extending in a northerly direction for a distance of 135 metres.
- (c) That a bus stop be installed on the east side of Waimairi Road commencing at a point 135 metres north of its intersection with Riccarton Road and extending in a northerly direction for a distance of 14 metres.
- (d) That the stopping of vehicles be prohibited at any time on the east side of Waimairi Road commencing at a point 149 metres north of its intersection with Riccarton Road and extending in a northerly direction for a distance of 32 metres.

11. APPLICATIONS TO RICCARTON/WIGRAM 2011/12 DISCRETIONARY RESPONSE FUND – HORNBY NETBALL CLUB AND RICCARTON RACECOURSE BOWLING CLUB
