1. DEPUTATIONS BY APPOINTMENT

1.1 WHITE ELEPHANT TRUST

Nathan Durkin of the White Elephant Trust addressed the Board on the youth activities that the Trust provides and outlined how these services have continued to be provided since the 22 February 2011 earthquake.

The Trust representatives would appreciate details of contacts in the Spreydon/Heathcote area that could assist the Trust in identifying any specific needs in this area of the city.

Board members were invited to visit the Trust.

The Chairperson thanked Nathan Durkin for presenting an outline of the Trust's good work to the Board.

1.2 HEATHCOTE RIVER – HABITAT PROTECTION

Mr Mark Crocker, a local resident, spoke to the Board concerning the mowing of grass on the banks of the Heathcote river by the Council and outlined its effect on the native flora and fauna. The mowing is taking place during the current breeding season for various duck and other bird species and destroying nests and nest sites. Decapitated ducklings have been discovered by people walking on the riverbanks. Mr Crocker also raised the matter of the mowing of new native grasses which the Council has recently planted along the riverbank. Mr Crocker asked the Board to investigate the effect of the mowing at this time on the habitat and fauna and to put in place measures to identify and protect specific nesting and new native grass growing sites.

The Board **decided** to request staff advice regarding the timing of the mowing and its effect on flora and fauna on the riverbank.

11. MATHERS ROAD AND WATERS STREET - PROPOSED NO STOPPING RESTRICTION

The Board considered a report seeking its approval that the stopping of vehicles be prohibited at any time at the intersection of Mathers Road with Waters Street.

The Board resolved to:

- (a) Revoke the following on Mathers Road:
 - (i) The existing parking restrictions applying at any time on the south side of Mathers Road commencing at the intersection with Waters Street and extending in a westerly direction for a distance of 12 metres;
 - (ii) The existing parking restrictions applying at any time on the south side of Mathers Road commencing at the intersection with Waters Street and extending in an easterly direction for a distance of 14 metres.
- (b) Revoke the following on Waters Street:
 - (i) The existing parking restrictions applying at any time on the eastern side of Waters Street commencing at the intersection with Mathers Road and extending in a southerly direction for a distance of 15 metres;
 - (ii) The existing parking restrictions applying at any time on the western side of Waters Street commencing at the intersection with Mathers Road and extending in a southerly direction for a distance of 15 metres.
- (c) Approve the following on Mathers Road:
 - That the stopping of vehicles be prohibited at any time on the south side of Mathers Road commencing at the intersection with Waters Street and extending in a westerly direction for a distance of 12 metres;
 - (ii) That the stopping of vehicles be prohibited at any time on the south side of Mathers Road commencing at the intersection with Waters Street and extending in a easterly direction for a distance of 14 metres.
- (d) Approve the following on Waters Street:
 - (i) That the stopping of vehicles be prohibited at any time on the eastern side of Waters Street commencing at the intersection with Mathers Road and extending in a southerly direction for a distance of 21 metres;
 - (ii) That the stopping of vehicles be prohibited at any time on the western side of Waters Street commencing at the intersection with Mathers Road and extending in a southerly direction for a distance of 21 metres.

12. 119 WORDSWORTH STREET PROPOSED P10 PARKING RESTRICTION
