#### 5. BRIEFINGS

# 5.1 IAN WHITEHEAD - OUTDOOR POOLS UPDATE

lan Whitehead, Southern Area Recreation Manager, briefed the Board on outdoor pools in Christchurch and other matters.

Members were updated regarding various matters related to recreation facilities in the community and in particular were advised that funds received from Kiwisport will be used to subsidise the transport costs associated with providing pupils with swimming lessons for those schools in the eastern suburbs who no longer have access to local pools. Further the Board were advised that more information regarding the earthquake damaged Waltham pool will be available in an updated aquatic strategy which will be available prior to Christmas.

Members were also further advised of upcoming Board events including the HoonHay Festival on 18 November 2011, the Waltham Event on 25 February 2012 and Barrington Big Fun on 26 February 2011.

### 6. EARTHQUAKE RECOVERY DESIGN AND CAPABILITY

### 6.1 FORMER WOOD BROTHERS MILL HERITAGE SITE - REDEVELOPMENT

Richmond Paynter, property developer and Raymond Edwards from Urbis Planning and Engineering addressed the Board regarding a proposed hospitality hub redevelopment of the former Wood Brothers flour mill including chimney and brick silo site in Addington. Mr Paynter explained that the building for redevelopment is dated from the 1890s and is a Group 2 building in Appendix 1, Section 10, Vol. 3 of the Christchurch City Plan. Items in this group are considered of national or regional importance protection, of which is seen as very important where this can be reasonably achieved.

Board members expressed the Board's support, in principle, for the project. In particular the Board expressed its support for the retention and redevelopment of the Wood Brothers former mill heritage building in the Addington area. The Board explored ways in which the Council might be able to work with the project development team including contact with Council project managers working on earthquake rebuild matters and possible greenspace development work around the appearance of the area.

The Chairperson thanked Messrs Paynter and Edwards for their presentation.

#### 11. NOTICE OF MOTION CONT'D

1.1 The Spreydon/Heathcote Community Board requests an urgent briefing from the Ministry of Economic Development and Environment Canterbury regarding Exploration Permits 52614, 52605 and 38264. The Board respectfully requests a reply by mid December 2011.

The Community Board wishes to hear:

- (a) whether the granting of permit 52614 and 52605 will allow hydraulic fracturing to take place in the Christchurch region. (See **attachment A** maps of both the permit areas.)
- (b) whether the above authorities will permit hydraulic fracturing to be used as an extraction method in the Christchurch region if Coal Seam Gas/Shale Gas is found.
- (c) whether the above authorities have considered, or will consider, the increase in seismic activity in the processing of 52614 and 52605.
- (d) what the results are from the exploration of the 38264 permit area and if deep sea drilling is likely to be required to extract petroleum there.
- (e) whether the Ministry of Economic Development will be extending 38264 beyond its expiration date on 7/11/2011.
- (f) whether the Ministry of Economic Development or ECan will be consulting with the public or the Council regarding all of the above.
- 1.2 Further that all information obtained on fracking be shared amongst all Canterbury Community Boards (Zone 5) and made available to the general public.
